Roll call - Quorum present.

Opening prayer by Chaplain, Bill Lockwood.

Ronald arrived at 2:45 PM.

Roy arrived at 3:07 PM.

This meeting was called to interview the three applicants for the superintendent's position here at the Fort Berthold Reservation.

The chairperson called on Mr. Ben Chevarria first, then Mr. Moran and last, Mr. Don Morgan. The three were interviewed and the chairperson stated that she would set the date for voting later.

Jerry stated that he needs authorization from the council for the chairperson to sign easements.
