Mark Larsen of CGG Seismograph Company for Exxon, Inc., presented an application for seismograph permit. Tom moved for approval. Second by Eva. On remarks, he was told that Theodore Bird Bear will be the contact person. VOTE: Sam, Austin, John, Roy, Wayne, Tom, Eva - YES. Seven in favor, none opposed, Chrp. not voting, motion carried.

Kon Reichert had an application for seismograph permit from Home Petroleum . Seven in favor, none opposed, Chrp. not voting, motion carried.

Austin moved for approval to grant permission for temporary access. Second by John. VOTE: Sam, Austin, John, Roy, Wayne, Eva - YES. Six in favor, none opposed, Chrp. not voting, motion carried.

Travel voucher for Ron Reichert for services rendered for the month of April in the amount of \$940.88. Roy moved for approval. Second by Eva. All in favor, none opposed, Chrp. not voting, motion carried.

A motion was made by Austin to have Ron Reichert order an official Tribal Election Board Stamp. Second by John. VOTE: Sam, Austin, John, Roy, Wayne, Eva - YES. Six in favor, none opposed, Chrp. not voting, motion carried.

Austin moved to have BIA draft a proper Constitution and By-laws, present it to the Council and after it is reviewed and found satisfactory, order copies and mail them to Tribal members. Second by John. VOTE: Sam, Austin, John, Roy, Wayne, Eva - YES. Six in favor, none opposed, Chrp. not voting, motion carried.

Perry Ross would like the Council to reconsider his request to have a well drilled on his land. Austin moved that the Tribal Business Council reconsider this request, also be given top priority by Public Health, to have a well drilled as soon as possible. Second by John.
