Meeting come to order at 1:45 p.m. Roll Call - Quorum present. Opening Prayer by John Stone, Sr.

Chair calls on Kenneth Charging on his case.

Kenneth stated that his two children, Lavina and Dallas had relinquished their enrollment at Lower Brule Sioux Tribe and reinstate enrollment here at Fort Berthold, Three Affiliated Tribes. Rose explains to the Council of what happened to these two children. That they had received benefits from that Tribe. This is the reason why Aberdeen Area Office refused their enrollment here at Fort Berthold, Three Affiliated Tribes, under dual enrollment ordinance. John moved that we accept the resolution on Council action. Second by Wayne. Vote: Eva, John, Tom, Austin, Wayne, Hazel-YES. Six in favor, none opposed, chrp. not voting, motion carried.

Wayne moved that we reaffirm the action of their enrollment, dated March 21, 1978; provided that they pay back that Sioux Benefit to Lower Brule Sioux Tribe. Second by Tom. Vote: Eva, John, Tom, Austin, Wayne, Roy, Hazel-YES. Seven in favor, none opposed, Chrp. not voting, motion carried.

Santee Pow-Wow Committee Chairman, Francis Standing Soldier requests a \$1,000 from Revenue Sharing funds for expenses.

Secretary reads Francis' letter.

Wayne moved to approve \$1,000 from Parshall's Revenue Sharing. Second by Austin. Vote: Eva, John, Tom, Austin, Wayne, Roy, Hazel-YES. Seven in favor, none opposed, Chrp. not voting, motion carried.

At this time, Max James resolution was presented. Tom Eagle explains the conditions of the weatherization Program. Also, Tom Mandan presented a budget for his Office. Secretary reads the resolutions.

Suni Blackfeather has the floor.

He stated that funds allocated for his Program were taken and put in BIA roads Zero Base Budgeting, signed by the Chairperson. He wanted the Council to put this money back into his program, where it should have been in the first place.

Tom moved that the next meeting, we meet with the BIA people, Program Directors, on this Zero Base Budgeting, Band Analysis. Second by Austin.
