Meeting was called to order at 10:50 am. Roll call; Quorum present.

LOAN:

The Secretary read resolution authorizing loan to Joan White Owl.

Blake moved to authorize emergency loan of \$500 to provide funds for escort for patient to US PHS Hospital, Seattle, Washington, to be repaid at \$75/per month from salary of Paul White Owl; second by Wells. Vote: Eight (8) in favor, Chair voting, motion carried. Resolution #79-142.

HOUSING:

Don Kellar reported there is an increase from 54 to 64 elderly units for Fort Berthold. The housing allocation is 25 rental and 20 mutual help units.

The site for the White Shield elderly units is a farm lease and an alternate site is to be explored.
