Secretary read resolution approving budget for Utilities Commission now a part of HIP/Weatherization.

Blake moved for approval of budget modification including salary increase for Max James; second by Little Owl. Vote: Seven (7) in favor, Chairman voting, motion carried. Resolution #79-216.

Secretary read resolution authorizing loan to Arts and Crafts Project.

Blake moved to authorize loan from T/2 account for Mandaree Arts and Crafts Project to be repaid from Mandaree share of funds from Docket 350 - C & D; second by Walker. Vote: Four (4) in favor, one (1) opposed, one (1) abstention, one (1) not voting, motion carried. Resolution #79-217.

#### CONDEMNATION:

Secretary read resolution concerning right of way for Carroll and Verna Smith. Pete Fredericks has refused right of way for the Smiths' and Mossetts'.

Little Soldier moved to authorize the Bureau of Indian Affairs to proceed with action for right of way for Carroll and Verna Smith; second by Yellow Bird. Roll Call Vote: Little Soldier, Yellow Bird, Eagle, Gillette, Walker, Wells - Yes; Little Owl, Blake - No; Chairman voting, motion carried. Resolution #79-218.

Roll Call Vote: Little Soldier, Eagle, Walker, Gillette, Yellow Bird - YES; Little Owl, Blake - NO; Five (5) in favor, two (2) opposed; Chairman voting, motion carried. Resolution #79-219.

#### APPEAL:

Secretary read resolution to support BIA on assessing John Fredericks for damages for tribal land.

Little Soldier moved to support action of the Bureau of Indian Affairs on damages to crop and grazing lands; second by Yellow Bird. Vote: Five (5) in favor, two (2) abstentions, Chairman voting, motion carried. Resolution #79-220.

## WILDLIFE PROPOSAL:

Secretary read resolution approving proposal for wildlife project.

Eagle moved to approve proposal for Cooperative Wildlife Project second by Walker. Vote: Seven (7) in favor, Chairman voting, motion carried. Resolution #79-221.

## ATTORNEY FEES:

Secretary read resolutions approving payment to Wilkinson, Cragun & Barker.

Eagle moved to authorize payment to Wilkinson, Cragun & Barker for services rendered from July through November 1978 in the amount of \$13, 628.49; second by Little Soldier. Vote: Seven (7) in favor, Chairman voting, motion carried. Resolution #79-222.

Eagle moved to authorize payment to Wlkinson, Cragun & Barker for services rendered December 1978 in the amount of \$3,102.42; second by Little Soldier. Vote: Seven (7) in favor, motion carried. Resolution #79-223.

Eagle moved to authorize payment to Wilkinson, Cragun & Barker for services rendered January 1979 in the amount of \$3,377.68; second by Little Soldier. Vote: Seven (7) in favor, motion carried. Resolution #79-224.
