Pete Coffey called the meeting to order at 2:25 p.m.

Secretary called Roll Call; Quorum present.

Dispatcher Lay-off - Amy Henry explained Shirley Sanders, a Jailer Dispatcher had requested that she be laid-off from her position due to medical reasons and is under a doctor's orders. Amy stated it would be an extended leave and she would probably not return to work until May of 1983. Dennis Huber made a motion to grant her request of being laid-off. Tillie Walker seconded the motion. Remarks: Paul asked is someone would fill her position. Amy said no, and that she had talked with Farrell Eagleman and he stated he would like the position to remain vacant as there are problems with the budget. Dennis made a recommendation to fill the position or have Farrell Eagleman attend a meeting to explain his position. Paul stated he would write the letter. Vote Call - Four in favor, 0 opposed, motion carried.

Commitment procedure - Kip explained the commitment procedure had been approved last week but when talking with the Parshall Rehab Center personnel, Tony Hale and Carol Parker of IHS a few minor changes had been made. Kip went over the commitment procedure.

Ernest Stone came into the meeting.

Discussion followed on the transportation problem of not having enough funds to provide transportation to institutions. It was stated by both Alvin Wells and Mike Yellow Bird the Parshall Rehab Center is on a very limited budget. Tonly Hale stated there is no follow-up work done after a respondent has been committed. Kip said it could be put within the Court Order and that a paraprofessional should be involved in these hearing to give expertise in the medical area and to have the Court follow it thru. Paul suggested a Liason be established between the Court and the Parshall Rehab Center. Paul moved to approve the Commitment procedure as presented by Kip. Ernest Stone seconded the motion. Vote Call Five in favor, O opposed, motion carried.

Parshall Rehab Center - Discussion followed on giving the Parshall Rehab Center a percentage of the D.W.I. fine to aid with expenses of the Center. Paul stated he was in favor of giving a percentage of every D.W.I. to the Center. Mike Yellow Bird gave a brief report on the standing of the Center and stated they had been cuts in funding and as of now they had no money for residental care. Paul made a motion to give 50% of every D.W.I. fine collected be given to the Parshall Rehab Center to aid and subsidize residental care for food and materials. Tillie Walker seconded the motion. Remarks: Dennis said it should be looked into more detailed to see if all the financial sources have been tapped and that the Tribal Court Administrator should be here. Vote Call - Four in favor, zero opposed, l abstained, motion carried.

Ernest brought up the bonding of magistrates in the White Shield and Twin Buttes area. Paul stated the bonding requirements have not yet been brought into the meeting. Dennis stated the person would have to be on call for 24 hours. Kip said holding people over 24 hours is not constitutional and must have someone there to accept bail. Tony Hale said during arraignments the bond is set and not every offense is a bond needed. Paul suggested to have Tony look into bonding people.

The resolution for the D.W.I. fine increase will be prepared by Kip for the next full Council meeting.

Kip brought up the Guardianship procedure. Dennis made a motion to adopt the guardianship procedure. Tillie seconded the motion. Vote Call - Five in favor, zero opposed, motion carried. Remarks: Kip will prepare the resolution and bring it up at the next full Council meeting.

Being no further business, meeting adjourned at 4:10 p.m.
