ITEM 1 CALL TO ORDER

Chairman Spotted Bear called the meeting to order at 11:15 a.m.

ITEM 2 ROLL CALL

Secretary Bird Bear called roll; quorum present.

ITEM 3 NATURAL RESOURCE DEPARTMENT

Motion No. 1 - Matt Mason moved, seconded by Ernest Stone for approval of meritorious raises for Celeste Eagleman and Fred Poitra in the Tribal Ranger Division from Parshall Ranger line item. Motion was amended to have an evaluation of all staff in the Ranger department. Three (3) in favor, two (2) opposed, motion carried.

Motion No. 2 - Nathan P. Goodiorn moved, seconded by Ernest Stone to authorize Hugh Baker contact Dennis Maddox regarding recovery of indirect cost paid from Game & Fish Division. Five (5) in favor, motion carried.

ITEM 4 BIA REALTY DEPARTMENT

Motion No. 3 - Nathan P. Goodiron moved, seconded by Gerald White to refer resolution regarding an investigation of the BIA Realty Department to the full Council at their next meeting, and to have Tribal Attorney present for any legal ramifications. Five (5) in favor, motion carried.

ITEM 5 OIL & GAS PROPOSAL

Motion No. 4 - Nathan P. Goodiron moved, seconded by Roy Bird Bear to authorize the Natural Resource Department to develop proposal to contract so they can investigate and audit royalty payments collected on oil wells on Ft. Berthold Reservation back to the first day of production. Five (5) in favor, motion carried.

## ITEM 16 TRIBAL PROPERTY

Addie Porter was asked to make a complete report regarding access, easements, etc. on a house and 10 acres of land purchased from Ed Hall.

Motion No. 13 - Roy Bird Bear moved, seconded by Ernest Stone to have the Tribe pay for an updated abstract on the property purchased from Ed Hall. Three (3) in favor, one (1) opposed, one (1) not voting, motion carried.

#### ITEM 17 GRAZING LEASE

Motion No. 14 - Roy Bird Bear moved, seconded by Ernest Stone for approval of grazing lease for Ed Hall for Allotment 549A, containing 81 acres for five (5) years beginning January 1, 1983, at \$3.50 per acre. Four (4) in favor, one (1) not voting, motion carried.

#### ITEM 18 GRAZING LEASE

Motion No. 15 - Matt Mason moved, seconded by Roy Bird Bear for approval of grazing lease for Weston Schettler for Allotment 214A, containing 40 acres for three (3) years beginning January 1, 1983 at \$3.00 per acre. Four (4) in favor, one (1) not voting, motion carried.
