Item No. 3 EVALUATION AND RECOMMENDATIONS FOR TRIBAL COURT SYSTEM

Motion No. 1 - Alyce Spotted Bear moved, seconded by Paul Good Iron, that Diane Johnson, Tribal Prosecutor, be given authority to conduct an evaluation of, and submit recommendations for, the Tribal Court System to the Judicial Committee for their review and approval. VOTE: All in favor, motion carried.

Item No. 4 PARSHALL REHABILITATION CENTER RECEIVING 50% OF FINES AND COSTS BUDGET

Motion No. 2 - Dennis Huber moved, seconded by Alyce Spotted Bear, that on June 1, 1983, the Judicial Committee will meet with Michael Yellow Bird, Human Resources Administrator and Tribal Court Administrator Wally Chase to discuss having 50% of the Fines and Costs budget line item going to the Parshall Rehabilitation Center. VOTE: All in favor, motion carried.

Item No. 5 HIRING OF TRIBAL POLICE OFFICER IN PARSHALL

Motion No. 3 - Dennis Huber moved, seconded by Alyce Spotted Bear, that Judicial Committee Secretary Paul Good Iron will contact Homer White Buffalo for a complete evaluation report of current Tribal Police Officer Sidney White Body in ninety (90) days. VOTE: All in favor, motion carried.

VOTE: Four (4) in favor, one (1) abstention. Motion carried.

Motion No. 5 - Paul Good Iron moved, seconded by Ernest Stone, that Wally Chase, Court Administrator, be given authority to sign all purchase orders and Tony Hale, Chief Judge, will sign all travel and mileage requests for payment (including trips, seminars, workshops, etc.). VOTE: All in favor, motion carried.
