Item No. 3 Motion No. 1 - Tillie Walker moved, seconded by Donald Malnourie, that the Committee approve Clarinda Baker, Assisstant Prosecutor, and Laurie O'Berry, Deputy Clerk of Court, switch job titles and duties and file letters in the Personnel Department to that effect. VOTE: Three (3) in favor, one (1) opposed, motion carried.

Item No. 4 TRIBAL PROSECUTOR REQUEST FOR TIME OFF

Motion No. 2 - Tillie Walker moved seconded by Paul Good Iron, that Diane Johnson, Tribal Prosecutor be approved for six weeks off to study for and take the bar exam refresher course in Denver, Colorado, from June 1 to July 27, 1983, with pay. During Tribal Prosecutor's absence, Clarinda Baker will take over her duties. VOTE: Three in favor, one (1) not voting, motion carried.

Item No. 5 FIFTY PER CENT OF DWI FINES & COSTS BUDGET GOING TO ALCOHOL REHABILITATION CENTER IN PARSHALL

Motion No. 3 - Paul Good Iron moved, seconded by Tillie Walker, to rescind the motion to give the Parshall Rehabilitation Center 50% of proceeds from Tribal Court DWI fines, due to lack of money. VOTE: All in favor, motion carried.

Item No. 6 TRIBAL COUNCIL PROVIDING LEGAL REPRESENTATION FOR TRIBAL POLICE OFFICERS

Item No. 9 USE OF LEAVE FOR TERO COMMISSIONERS TO ATTEND CONFERENCE

Tillie Walker moved, Paul Good Iron seconded, that Mike Cross, TERO Board of Commissioners, will also use his personal leave time to attend TERO Conference in Wyoming for the three days of the conference, and will also have his pay withdrawn for those three days. VOTE: All in favor, motion carried.

Motion No. 8 - Paul Good Iron moved, seconded by Donald Malnourie, that Tony Hale, Chief Judge, sign off on Wally Chase, Court Administrator's time sheet, also for Juvenile Judge time sheet; Court Administrator will sign off on the rest of the Tribal Court staff's time sheets. VOTE: All in favor, motion carried.
