ITEM NO. 19 OGLALA SIOUX TRIBE RESOLUTION TO ABOLISH ABERDEEN AREA OFFICE

Motion No. 18 - Treasurer Huber moved, seconded by Councilwoman Wells to develop a resolution similiar to the Oglala Sioux Tribe asking for abolishment of the Aberdeen Area Office and to deal directly with the Central Office in Washington, D. C. in order to strengthen local tribal government by giving the Superintendent more approval authority. Vote: Nine (9) in favor, motion carried. Resolution No. 83-130-S

ITEM NO. 20 RESERVE STATUS FOR TRIBAL LAND

Motion No. 19 - Councilwoman Wells moved, seconded by Councilman Malnourie for approval of tribal land, Allotment 531A, containing 80 acres to be placed in reserve status for the use of the Game and Fish Division. Vote: Nine (9) in favor, motion carried: Resolution No. 83-131-S

ITEM NO. 21 SHOTHOLE AND RELATED FEES

Motion No. 20 - Councilman White moved, seconded by Secretary Mason for approval of having all shothole fees and related fees collected by the Permitting Office on Corps land for use by the Natural Resources Department. Vote: Seven (7) in favor, two abstentions, motion carried. Resolution No. 83-132-S

ITEM NO. 22 ENVIROMENTAL QUALITY DIVISION

Motion NO. 21 - Councilman Malnourie moved, seconded by Coucilwoman Wells for approval of the Three Affiliated Tribes requesting the Environmental Protection Agency to continue to fund the two existing environmental quality components and also the proposed Safe Drinking Water Component at the rates prescribed by the applicable regulations. Vote: Eight (8) in favor, one (1) not voting, motion carried. Resolution No. 83-133-S

ITEM NO. 23 RENOVATION OF STREETS

Motion No. 22 - Councilman Malnourie moved, seconded by Councilman Coffey to table resolution to renovate streets adjacent to tribal lots in the amount of \$8,710.00. Vote: Eight (8) in favor, one (1) not voting, motion carried.

ITEM NO. 24 FT. BERTHOLD COMMUNITY COLLEGE

Motion No. 23 - Vice Chairman Walker moved, seconded by Councilwoman Wells to reaffirm support of the three (3) resolution passed,"82-162, 82-163 and 820164", by the previous Council in 1982. Vote: Nine (9) in favor, motion carried.

Motion No. 24 - Councilwoman Wells moved, seconded by Councilman Malnourie for approval of \$5,000 to the Ft. Berthold Community College, with Tribal Treasurer determining line item. Vote: Six (6) in favor, one (1) opposed, one (1) abstention, one (1) not voting, motion carried. Resolution No. 83-143-S

On the requested changes, the Council requested a separate resolution for each of the changes, showing changes, amendments, etc. and Treasurer Huber will do research on the money part.

ITEM NO. 25 AGRICULTURAL & RANGE IMPROVEMENT PROJECT

Motion No. 25 - Secretary Mason moved, seconded by Councilman Malnourie for approval of the Three Affiliated Tribes' Tribal Council requesting Bureau of Indian Affairs to enter into a contract for the Agricultural and Range Improvement project in the amount of \$280,000, with further resolve that the Natural Resources Department be authorized to administer the contract. Vote: Seven (7) in favor, two (2) not voting, motion carried. Resolution NO. 83-135-S

ITEM NO. 26 ALCOHOLISM PROGRAM (REHAB. CENTER)

Motion No. 26 - Secretary Mason moved, seconded by Councilman Stone for approval of the Tribal Business Council authorizing Tribal Treasurer Huber to borrow \$10,000 from a bank to rund the Rehabilitation Center located in Parshall until June 15, 1983, with further resolve that the loan plus interest will be repaid from the 20% share of interest on Docket 350 G, funds specified (7.5%) for alcoholism. Vote: Five (5) in favor, two (2) opposed, two (2) not voting, motion carried. Resolution No. 83-136-S

ITEM NO. 27 OHOYO CONFERENCE

Motion No. 27 - Councilman Malnourie moved, seconded by Councilman White to authorize travel for the women on the Council to attend a conference for Indian women in Grand Forks on June 9-12, 1983. Vote: Seven (7) in favor, two (2) not voting, motion carried.
