## NATURAL RESOURCE MEETING TRIBAL BUSINESS COUNCIL JUNE 6, 1983

CALL TO ORDER (Item No. 1)

The meeting was called to order by Paul Good Iron, Acting Chairman at 1:45 PM appointing Gerald White as Secretary.

ROLL CALL (Item No. 2)

Roll call, quorum present to conduct business.

ITEM NO. 3 EASEMENT FOR PROJECT AHL 31(5)(8)

MOTION NO. 1 - Motion was made by Gerald White to have Paul Howling Wolf do a title search on the ownership of the strip of land lying in the NE<sup>1</sup><sub>4</sub>, Sec. 27, T. 152 N., R. 93 W. containing 1.74 acres more or less that the Mountrail County was asking the Tribe for a construction easement for the Little Shell Road, SECONDED by Ernest Stone. VOTE: 4 in favor, MOTION CARRIED.

ITEM NO. 4 LEASE REQUEST ON ALLOT 1093A FOR MAUREEN FEVOLD

It was recommended to table until information on a resolution establishing rates can be presented at their next meeting.

ITEM NO. 5 RESOLUTION REQUESTING CORP. LAND BE DECLARED RESERVE STATUS

It was decided that the resolution be tabled until a more detailed map was presented as to where these lands are, how many acres, the extent of the boundary on the shoreline and easements, if any, are involved.

#### ITEM NO. 6 ANNA MC GRADY & JON MC GRADY LAND EXCHANGE

MOTION NO. 2 - Motion was made by Dennis Huber to approve and refer to the full council in resolution form the land exchange of Anna McGrady and Jon McGrady Allot# 49, 1563 and 637A for Tribal land Allot# T743A, with a waiver by McGrady's for the monetary difference, SECONDED by Gerald White. VOTE: 4 in favor, MOTION CARRIED.

#### ITEM NO. 7 CLYDE PLENTY CHIEF LAND EXCHANGE

MOTION NO. 3 - Motion was made by Gerald White to approve the land exchange of 20 acres for 20 acres with a monetary difference of about \$200.00 to be waived by Glenda Good Bird upon final approval from the full council at their next meeting, SECONDED by Ernest Stone. REMARKS: None. VOTE: 3 in favor, 1 not voting, MOTION CARRIED.

#### ITEM NO. 11 APPLICATION TO LEASE TRIBAL LAND FROM WESTON SCHETTLER

MOTION NO. 4 - Motion was made by Gerald White to approve Weston Schettler's application to lease Allot# 214A for 120 acres for 3 years at \$3.50 per acre, SECONDED by Ernest Stone. VOTE: 3 in favor, 1 not voting, MOTION CARRIEI

### ITEM NO. 12 APPLICATION TO LEASE TRIBAL LAND FROM BILLADEAU BROS.

MOTION NO. 5 - Motion was made by Gerald White to approve the application from Billadeau Bros. to lease Allot# 1392, 40 acres cultivated with Tribes owning 1/4 and 1/4 being owned by Annette Packineau, at 1,000 cash rental for 3 years SECONDED by Ernest Stone. VOTE: 3 in favor, 1 not voting, MOTION CARRIED.

ITEM NO. 13 JOHN FREDERICKS LEASE APPLICATION

MOTION NO. 6 - Motion was made by Gerald White to rescind lease application Allot# T704A previously awarded to John Fredericks and for John Fredericks to submit a new application containing what he desires with the correct information, SECONDED by Ernest Stone. VOTE: 3 in favor, 1 not voting, MOTION CARRIED.

ITEM NO. 14 CELESTE WITHAM LEASE APPLICATION

MOTION NO. 7 - Motion was made by Gerald White to approve Allot# 432A for Celeste Witham at 4 years at \$8., \$25., \$25., \$25., SECONDED by Ernest Stone. VOTE: 3 in favor, 1 not voting, MOTION CARRIED.
