

Judicial Committee Meeting
June 22, 1983

CALL TO ORDER (Item No. 1)

Acting Chairman Paul Goodiron called the meeting to order at 2:00 p.m., on June 22, 1983. Ernest Stone was appointed as Acting Secretary.

ROLL CALL (Item No. 2)

There being a quorum present, the meeting was ruled in order to conduct business.

Item No. 3 PL93-638 CRIMINAL JUSTICE BUDGET APPROVAL

Motion No. 1 - Alyce Spotted Bear moved, seconded by Ernest Stone, to approve the second budget submitted by Court Administrator Wally Chase for adoption by the Committee, and that the matter of the Legal Department picking up 2/3 of the Tribal Prosecutor's salary be referred to the full Council. VOTE: All in favor, motion carried.

Item No. 4 RETROACTIVE PAY FOR EVANGELINE WHITE BULL & OTHER COURT EMPLOYEES

Motion No. 2 - Alyce Spotted Bear moved, seconded by Ernest Stone, to approve backpay retroactively, for all Tribal Court employees, including Evangeline White Bull for the time that she was employed by the Tribal Court. VOTE: All in favor, motion carried.

Item No. 5 PAYMENT SCHEDULE FOR MAGISTRATE JUDGES

Motion No. 3 - Alyce Spotted Bear moved, seconded by Ernest Stone, to disapprove paying \$30.00 per day to the Magistrate Judges, but still pay mileage for their performance in the absence of the Chief Judge. VOTE: All in favor, motion carried.

Item No. 6 THOMAS ALBERTS REQUEST FOR PAYMENT OF COMPENSATORY TIME

Motion No. 4 - Alyce Spotted Bear moved, seconded by Ernest Stone, that compensatory time not be paid in Thomas Alberts' case, because it is not allowed for in the budget and that he was aware that he would not be paid for compensatory time and signed an employee agreement to that effect. VOTE: All in favor, motion carried.

Item No. 7 APPROVAL OF MINUTES

Motion No. 5 - Ernest Stone moved, seconded by Alyce Spotted Bear, to approve the minutes of April 20, 1983. VOTE: All in favor, motion carried.

Motion No. 6 - Ernest Stone moved, seconded by Alyce Spotted Bear, to approve the minutes of May 11, 1983. VOTE: All in favor, motion carried.

Motion No. 7 - Alyce Spotted Bear moved, seconded by Ernest Stone, to approve the minutes of May 18, 1983. VOTE: All in favor, motion carried.

Motion No. 8 - Alyce Spotted Bear moved, seconded by Ernest Stone, to approve the minutes of May 25, 1983. VOTE: All in favor, motion carried.

Motion No. 9 - Ernest Stone moved, seconded by Alyce Spotted Bear, to approve the minutes of June 15, 1983, with corrections. VOTE: All in favor, motion carried.

Item No. 8 WITHDRAWAL OF JUVENILE JUDGE POSITION ADVERTISEMENT

Motion No. 10 - Alyce Spotted Bear moved, seconded by Ernest Stone, that the advertisement of the Juvenile Judge position be withdrawn at this time. VOTE: All in favor, motion carried.
