Sadie Mann's request for assistance from the Tribe in the amount of \$100.00 to obtain a propane tank was referred to the CIP Program.

ITEM 5 LETTER FROM NORTH SEGMENT COMMUNITY

A letter regarding an article published in Ahead of the Herd newspaper concerning audit and Council travel was presented to the Council by Tex Lone Bear, Community Chairman. The letter asked for an official response, and Matthew Mason, representative from North Segment, was requested to give them one at their next community meeting with copies of audit.

ITEM 7 BIA HIGHER EDUCATION

Mr. Gregory presented options to the Council regarding AFDC clients' policy as it pertains to loans and grants for education. North Dakota Social Services will consider Bureau grants as a resource and will be deducted from their needs standard as income. The Council decided to go with Option #3, to have Bureau pay only tuition, books and fees only, and see if State will exempt that. Mr. Gregory will be in touch with the Council when he finds out.

ITEM 10 COMMUNITY DEVELOPMENT FUNDS

Motion No. 10 - Secretary Mason moved, seconded by Councilman Stone to have the Tribal Council return Community Development funds to communities, which has been currently used in Tribal budgets. Treasurer Goodiron will do research when he returns. Eight (8) in favor, one (1) opposed, motion carried.

ITEM 11 SMOKE SHOP

Motion No. 11 - Councilman White moved, seconded by Councilwoman Wells for approval of issuance of a business license to Darlene Overlie for a smoke shop. Eight (8) in favor, one (1) abstained, motion carried.

ITEM 12 TRIBAL COMPTROLLER

The Council, after dicussion, decided to place on agenda for their next meeting, a resolution regarding Dennis Maddox and the training he has received through the Tribe, that he has to train an enrolled member in the event that he has to leave present employment.

ITEM 13 TRIP AUTHORIZATION

Motion No. 12 - Councilman Huber moved, seconded by Councilman White for a trip authorization for Rich Schilf of the Tribes' Natural Resource Department and Bob Martin of CERT, D. C. for a meeting in San Francisco regarding proposed Indian Surface Mining Control and Reclamation Act on November 14, 1983. Six (6) in favor, one (1) opposed, two (2) abstained, motion carried.

ITEM 14 BUSINESS DEVELOPMENT FUND

Motion No. 13 - Councilman White moved, seconded by Councilman Coffey to have Ken Deane, Tribal Planner, involved in the planning process of the Business Development Fund and to present proposed plans at next full Council meeting. Eight (8) in favor, one (1) abstained, motion carried.

Motion No. 14 - Councilman Huber moved, seconded by Councilwoman Wells to have Secretary Mason sent a telegram on behalf of the Tribes to Senators Andrews and Burdick to support SR 127 and get it on the Senate
