CALL TO ORDER

Committee Chairman Alyce Spotted Bear called the meeting to order at 11:15 a.m.; Roy Birdbear, Secretary, called the roll.

There being a quorum present, the meeting was ruled in order to conduct the business of this Special Meeting.

Item No. I NORMAN BAKER FARM LEASE

Motion No. 1 - Matthew Mason moved, seconded by Roy Birdbear, to approve Norman Baker's farm lease application at the rate of \$5.00 per acre for the first year, and \$7.50 per acre for the next four (4) years, in the NE¼, Section 19-149-91, 47.0 acres more or less of uncultivated farmland. This land is leased to Mr. Baker to grow alfalfa for use as a feed base for his stock, and the farmland is old and must be replowed and reworked, hence the \$5.00 per acre for the first year and \$7.50 for the remaining years. The condition was made by the Committee that this lease does not set a precedent for other and future leases similar to it. If this type of lease begins to arise with frequency, the Committee will set a policy regarding the lease amount. VOTE Three (3) in favor, none opposed. Motion carried.

Item No. II MARK CHARGING HOME SITE LEASE

Motion No. 2 - Matthew Mason moved, seconded by Roy Birdbear, to approve Mark Charging's home site lease at the rate of \$25.00 per year cash rental, W½NW¼SE¾NE¼SE¾W½NE¼SE¾NE½SE¾, Section 549A-152-93, 2.5 acres. VOTE Three (3) in favor, none opposed. Motion carried.

Item No. III PHOEBE DIXON LAND EXCHANGE

Matter was tabled due to the fact that Shirley Myrick lives on or near the land in question and has a homesite lease until 1985. The Committee recommended that she receive a letter notifying her of the pending land exchange and that she sign a receipt stating that she has received this notice. In the future, the Committee added, whenever an individual has been living on a site that is going to be exchanged or sold, or where the site in question is near the homesite of another individual, that individual should be notified prior to any kind of action being taken. Matter will be reconsidered after Shirley Myrick is notified in the manner prescribed by Committee.

Item No. IV GRETA WHITE CALF FARM PASTURE LEASE

Motion No. 3 - Matthew Mason moved, seconded by Roy Birdbear, to approve the farm pasture lease of Greta White Calf of Allotment 476A of the Taking Area. VOTE Three (3) in favor, none opposed. Motion carried.

Item No. V ED HALL FARM PASTURE LEASE

Motion No. 4 - Roy Birdbear moved, seconded by Matthew Mason, to grant the renewal of Ed Hall's farm pasture lease for three (3) years at \$350.00. VOTE Three (3) in favor, none opposed. Motion carried.

Ernest Stone entered the Meeting at 11:25 a.m.

Item No. VI RIGHT-OF-WAY - McKENZIE ELECTRIC

Motion No. 5 - Ernest Stone moved, seconded by Roy Birdbear, that McKenzie Electric be granted permits to put up electricity poles on two sites, being Section 28-151-94 and Section 2-149-94, which are homesites under construction. The Committee added the provision to both permits that a clause must be attached to the permit that it is for twenty-five (25) years and not for ninety-nine (99) years. That clause will be the one written previously by Christopher D. Quale, Supervising Attorney of the Tribal Legal Department. In the future, said twenty-five (25) year provision will be attached to all such permits. VOTE Four (4) in favor, none opposed. Motion carried.

Item No. VII NRD LAY-OFFS

Barbara Baker formally made the Committee aware that due to lack of funding it is necessary at this time for the Natural Resources Department to lay off some of its workers. Funds are being sought and will continue to be sought for important projects of NRD. One very important project is the updating and consolidation of land sale/exchange applications presently being undertaken by NRD personnel.

Item No. VIII LAND SALE/EXCHANGE APPLICATIONS

Adeline Porter presented forty (40) applications from Donna Lonefight Conklin. Ms. Conklin wants to sell all her interests in these to the Tribes. It is not presently known if buying her shares would indeed give the Tribes a controlling interest in these tracts of land: If it would, it would be worth the Tribes' effort to look into these and carry through with the appraisals. It is also not known presently if any other individuals owning interests in the tracts are also intereste in selling. This is one of the things that the project being carried out by NRD at this time in updating and consolidating land sale/exchang applications will facilitate. The Committee decided to help Ms. Conklin to contact the other owners in the forty (40) tracts of land to see how many of them are also interested in selling

Barbara Baker said NRD has been trying to assist the Committee in wiping out the backlog in these applications at the Bureau and has

been working on this for four (4) months now. The Committee members were presented with a copy of a memorandum from Natural Resources Department's Administrator explaining the Department's proposed approach to handling the work and were asked to comment on it. The Committee agreed with the approach but cautioned NRD to individually notify each individual who has an application on file and asked that BIA Realty help to notify all these individuals. Also, the Committee cautioned against closing out any applications without express authority from the individual who made the application. Baker assured them that this would be done.

Item No. IX NRD REQUEST TO UTILIZE EXCESS MONIES IN LANDS DEVELOPMENT ACCOUNT

Motion No. 6 - Matthew Mason moved, seconded by Roy Birdbear, to send the resolution of the Natural Resources Department requesting use of monies in the Lands Development Account for salaries in the Department on to the full Council. VOTE Four (4) in favor, none opposed. Motion carried.

Item No. X HIGHWAY 22

Barbara Baker presented the Committee with copies of a letter from the State of North Dakota setting out the requirements for the reconstruction of parts of Highway 22. The Committee commented that since the State is requesting the Tribes to get easements and rights-of-way from Tribal members, and Natural Resources Department is the entity that would have to do that work and is presently not financially able to proceed with it, and since the Tribes do not presently have the monies necessary to accomplish this task, the State of North Dakota fund the NRD to accomplish the task.

Item No. XI OTHER BUSINESS

Chairman, Alyce Spotted Bear, suggested to Barbara Baker that NRD develop a proposal or a request to use some money from BIA Realty to keep NRD functions going, especially with regard to Land sale/exchange work. The Committee will back up the request of NRD.

There being no further business to come before the meeting, the special meeting of the Natural Resources Committee was adjourned at 12:35 p.m.
