MATERIAL RESOURCE COMMITTEE MINUTES September 13, 1984

## Call to Order (Item No. 1)

Chairman Malnourie called the meeting to order at 10:45 A.M.

# ITEM NO. 3 MINUTES

Motion No. 1 - Moved by White to approve minutes of August 22, 1984 and September 5, 1984 with corrections, seconded by Coffey. Vote: Unanimous, motion carried.

Remarks: Gerald White commented that we should comply with housing regulations checking on current value of a home before approving a project. The committee requested copies of HIP and CDBG Housing Rehabilitation Regulations.

THEODORA VIGEN REQUEST - Steve informed the committee that the cost estimate to fix Theodoras home is \$5,000 for siding, insulation and windows. Tabled until the department receives cost information from Stephens Lumber.

# ITEM NO. 5 HOUSING REHABILITATION

Steve presented a list of applications currently on file stating that the list must prioritized. Steve commented, that according to the CDBG Application any HUD home over 5 years can be fixed, and that he couldn't find any regulations saying that the homeowner must be current with their rent. Steve asked the committee if there was a resolution to this effect. Jerry stated that there is no resolution, and that it was a verbal agreement between the housing authority and Material Resource. The Housing Authority will be called on to attend the next committee meeting so that a policy may be drawn up specifying that a homeowner be current with rent in order to receive housing rehabilitation.

Fort Berthold Housing Maintenance Reserve - Steve explained that homeowners who pay anything over \$45 a portion of that amount is set aside in the maintenance reserve, and they may use it if they are current with their rent.

Paul White Owl Request - Steve informed the committee that Paul had work done on his well/sewer and drainfield and is requesting payment to Buzz Lindley for the work. The payment requested is \$2,500. Tabled until the department receives a budget balance in CDBG Housing Rehabilitation.
