ITEM 1 CALL TO ORDER

Chairman, White Bear, called the meeting to order at 1:07 P.M.

ITEM 2 ROLL CALL

Secretary, Coffey, called roll, quorum present; (3 Members present with
2 Tribal Council Members sitting in).

ITEM 3 INDIAN COMMISSION MEETING IN ABERDEEN, SD

MOTION NO. 1 - Moved by Gordon Blake, seconded by Pete Coffey to approve
travel for the Transportation Committee members and Gordon Blake to
attend the meeting in Aberdeen, South Dakota with the Indian Commission,
on January 23, 1985.

REMARKS: The members are to let Pemina Yellow Bird, Administrative
Assistant of the Tribal Business Office, know if they are going to the
meeting so she can prepare travel for them.

VOTE: Unanimous, motion carried.

ITEM 4 RESPONSIBILITIES OF THE TRANSPORTATION COMMITTEE

DISCUSSION: Mr. Ray Kipling told Chairman White Bear that the main
duty of the Transportation Committee should be to keep the main roads
clear of snow and keep them in good condition.
The second responsibility would be the maintenance of private owned
roads. Some people can't get to their homes when the snow is really
piled up and the BIA can only help if it is a case of an emergency,
for instance, the family needs groceries, somebodys real sick and needs
transportation to the hospital, or to check on senior citizens.

ITEM 5 EQUIPMENT TO MAINTAIN THE ROADS

DISCUSSION: Mr. Ray Kipling was very helpful in letting the Committee know where some of the equipment was, and who the state licensed operators were. The Transportation Committee will have to meet with the Utilities Commission to ask about some of their equipment.

ITEM 6 ALYCE SPOTTED BEAR, TRIBAL CHAIRPERSON, ENTERED THE MEETING AT 1:40 P.M.

ITEM 7 MAINTAINER

MOTION NO. 2 - Moved by Gordon Blake, seconded by Bobby Bell that the first priority of the Transportation Committee is to get the maintainer in running operation to be used for the present winter season for off roads clearance.

REMARKS: The Maintainer is stalled in Twin Buttes, it will need a new battery and Ray Kipling said the Committee could use their garage to get it repaired and in running condition. Mr. Clifford Mossett was suggested to drive the machinery back to New Town, or onto a transporter, since he has a State Operators License and a Government License.

VOTE: Unanimous, motion carried.

DISCUSSION: Chairperson, White Bear, and Gordon J. Blake will approach Dennis Huber concerning the road graders.

ITEM 9 SCHEDULE FOR NEXT TRANSPORTATION COMMITTEE MEETING
