MOTION NO. 1 - Moved by Pete Coffey, seconded by Ernest Stone to approve the minutes of the Judiciary Committee meeting on December 12, 1984, with no corrections.

VOTE: Unanimous, motion carried.

ITEM 4 KINGDOM BLACK HAWK - TRESPASSING ON HIS PASTURES

DISCUSSION: Chairperson, Paul Good Iron, told Mr. Black Hawk that he would have to go to the Tribal Court House and have a complaint drawn up and from there it will be investigated. Paul said he will also get in contact with the Bureau of Indian Affairs Range Department and they will try to take care of it.

ITEM 5 EXCESS RIFLES AND HAND-GUNS TO BE AUCTIONED OFF

MOTION NO. 2 - Moved by Pete Coffey, seconded by Donald Malnourie to have Paul Good Iron draft up a report on the rifles for the next Committee mmeting. A list of the rifles for advertising, and to define whether it will be an oral auction or sealed bids. Paul Good Iron is to report all this information at the next Judiciary Committee meeting.
