approve the resolution which agrees to the contents of the revised Tribal
Code, and approved the Native American Rights Fund revised Tribal Code
effective immediately and that amendments to the Tribal Code will be by
resolution to coincide with Federal/Indian law changes, and to refer
this to the Full Tribal Business Council for their approval.

VOTE: Three (3) in favor, one (1) abstaining, motion carried.
