Item No. 7      PROPOSED VEHICLE PURCHASE

Motion No. 4 - Tillie Walker moved, seconded by Donald Malnourie,  
to direct Committee Chairman Paul Good Iron to explore the purchase  
of a vehicle for Tribal Court, utilizing the Travel line  
item monies. VOTE: All in favor, motion carried.

Item No. 8      SEPARATION OF POWERS

There being no formal motions made regarding this topic, a brief synopsis is included here due to the relative importance of subject material.

Raymond Cross, Tribal Attorney, delivered a presentation regarding the Tribe's options in creating a separation of powers between the Tribal Government and the Tribal Court. Several ideas and potential obstacles were discussed, and Mr. Cross provided the Committee with information pertaining to various methods to take in achieving separation of powers. The outcome of the discussion was a directive given to Mr. Cross to provide the Committee with materials which outline all options to consider regarding the proposed separation of powers.
