PRESENT: EMDUND WHITE BEAR, PETE COFFEY SR., PAUL GOOD IRON, TILLIE WALKER

ABSENT: JOHN CHARGING, DON MALNOURIE., ALYCE SPOTTED BEAR. Let the record show that Alyce Spotted Bear is in Wahpeton, addressing the graduating class of Wahpeton Indian School.

ITEM 1 CALL TO ORDER

Acting Chairman, White Bear, called the meeting to order at 10:41 A.M. and appointed Paul Good Iron as Acting Secretary.

ITEM 2 ROLL CALL

Acting Secretary, Good Iron, called roll; quorum present (3 Members present).

ITEM 3 CHAPTER I APPLICATION

Discussion was held on the authorized signature for the Chapter I application for Bureau of Indian Affairs and contract schools. The authorized signer is Alyce Spotted Bear, per the recent resolution that was passed.

ITEM 4 PART 100 OF THE P.L. 93-638 CONTRACTS

Angelita Felix informed the Committee that she will be requiring more specific information for the Part 100 of all contracts in an effort to provide continuity and to determine more specifically whether progress is being made toward the contract goals. Proposed standard contract language from OIEP was reviewed.

ITEM 5 NATIONAL ADVISORY COUNCIL ON INDIAN EDUCATION

MOTION NO. 1 - Moved by Paul Good Iron, seconded by Tillie Walker to direct the Committee Chairman to write a letter to the National Advisory Council on Indian Education, in support of the Bureau's funding of preschool students who are ineligible to attend Head Start schools.

VOTE: Unanimous, motion carried.

ITEM 6 SENATE BILL 830

MOTION NO. 2 - Moved by Paul Good Iron, seconded by Tillie Walker to direct the Committee Chairman to write a letter to Congressional delegates regarding Senate Bill 830, to protest the proposed 25% set-aside of Indian Education monies specifically for Hawaiian natives, and suggesting that the total budget be increased by 25%, and that amount be set aside for Hawaiian natives.

VOTE: Unanimous, motion carried.

ITEM 7 PROPOSED RULE ON ISEP ELIGIBILITY

The proposed rule on ISEP eligibility from the Federal Register was reviewed and discussed. The Agency Superintendent for Education was requested to draft comments and submit to the Acting Chairman, Edmund White Bear. Comments are due by June 10, 1985.

ITEM 8 ATTENDANCE BOUNDARIES

Discussion was held on the attendance boundaries regulations and their relation to the Fort Berthold School System. The approved attendance boundaries will need to be reconsidered and Tillie Walker suggested that for the coming school year, reservation-wide attendance boundaries be effective. OIEP will need to approve this.

ITEM 9 SPECIAL ED. - P.L. 94-142

Angelita Felix stated that Bernadine Young Bird has previously assisted the schools with their P.L. 94-142 applications, and will continue to do so. The Committee was informed of the various special education amounts for the respective schools and the agency. It was pointed out \$92,864 was received by the Twin Buttes School.

ITEM 10 CONTRACT SCHOOL SOURCES OF FUNDING

Information on Mandaree and Twin Buttes sources of funding was presented for review by the Education Committee. The information was prepared as per a Congressional Request from Central Office. The Committee requested information on the White Shield for the next meeting. A review of a budgetary breakdown request concerning audit line items for the Twin Buttes School was completed. Another request for a more specific breakdown will be made.

ITEM 11 P.L. 93-638 APPLICATIONS

MOTION NO. 3 - Moved by Tillie Walker, seconded by Paul Good Iron to refer the 93-638 application to the 638 Board in Mandaree and to the State Board in Twin Buttes for completion under the signature of Alyce Spotted Bear, Tribal Chairperson.

VOTE: Unanimous, motion carried.

ITEM 12 P.L. 95-561 CONTRACTS

MOTION NO. 4 - Moved by Tillie Walker, seconded by Paul Good Iron, that the Tribal Education Committee, which will serve as the Agency School Board shall sign off on the P.L. 95-561 contracts and the Financial Program Plan at the Agency Office.

VOTE: Unanimous, motion carried.

ITEM 13 STANDING ROCK SPECIAL EDUCATION COMMITTEE

MOTION NO. 5 - Moved by Tillie Walker, seconded by Paul Good Iron that the Tribal Education Committee support the Standing Rock Special Education Cooperative as an alternative to utilizing the Cooperative with Pierre Indian Learning Center.

VOTE: Unanimous, motion carried.

ITEM 14 ADJOURNMENT

The meeting was adjourned at 1:38 P.M.
