#### ITEM 1 CALL TO ORDER

# ITEM 4 P.L. 94-142 SPECIAL EDUCATION - LANDMARK LEGISLATION

DISCUSSION: Angelita Felix stated this packet was put together so the Education Committee will know what the purposes of Special Education are and the process associated with applying for this supplemental money. White Shield, Mandaree, and the Agency have their LEA Application for review.

## ITEM 5 P.L. 94-142 LEA APPLICATION - WHITE SHIELD SCHOOL

Clifford Joe Fox, Principal of White Shield School, gave a presentation to the Tribal Education Committee regarding the Budget Summary of the White Shield School Application for Education of The Handicapped Act, P.L. 94-142.

MOTION NO. 1 - Moved by Paul Good Iron, seconded by John Charging that the Tribal Education Committee approves the P.L. 94-142 application for the White Shield School.

REMARKS: John Charging suggested getting some type of planning process for contracting under one Tribal program. In-service for the Education Committee was mentioned by Angelita Felix, and in that process to get someone to develop an organizational plan for the Tribal Education Department, of which Special Education would be one area.

VOTE: Unanimous, motion carried.

#### ITEM 6 P.L.94-142 LEA APPLICATION - MANDAREE SCHOOL

MOTION NO. 2 - Moved by Tillie Walker, seconded by Don Malnourie that the Tribal Education Committee approves the P.L. 94-142 application review for the Mandaree School.

REMARKS: Mandaree requested one full-time Resource Teacher certified in EMH/LD and the position will cost \$26,912,53, and travel/transportation in the amount of \$600.00 for the full-time resource teacher and the full-time aide.

VOTE: Unanimous, motion carried.

#### ITEM 7 P.L. 94-142 LEA APPLICATION - FORT BERTHOLD AGENCY

MOTION NO. 3 - Moved by Tillie Walker, seconded by Don Malnourie that the Tribal Education Committee approves the P.L. 94-142 Application for Education of the Handicapped Act, for the Fort Berthold Agency.

REMARKS: Dr. Felix, said they are usually commended, by the Chief from the Division of Exceptional Education, on how concise and complete there application is.

VOTE: Four (4) in favor, one (1) not voting, motion carried.

MOTION NO. 5 - Moved by Tillie Walker, seconded by Donald Malnourie that the unobligated monies left in In-service Training. which have to be spent by the end of this month, in the amount of \$600, will be used for In-service Training for the Tribal Education Committee.

VOTE: Unanimous, motion carried.

#### ITEM 12 TWIN BUTTES 638 CONTRACT

MOTION NO. 6 - Moved by Tillie Walker, seconded by Paul Good Iron that Tribal Attorney, Christopher 'Kip' Quale, explore the issues remodifying Resolution No. 84-76-S concerning the Twin Buttes School District #37, making the Three Affiliated Tribes the prime contractor for all school districts and for all such contracts to be for a period of one (1) year.

VOTE: Four (4) in favor, one (1) not voting, motion carried.
