ITEM 5 PRIORITIZE ROUTES FOR CONSTRUCTION

MOTION NO. 2 - Moved by Paul Good Iron, seconded by Don Malnourie to approve the road priority list for 1987 to include the 'Figure Four Road' three (3) miles at \$450,000 and the second being Route 27, Wells and Snow Road for 1987 combined of 8.7 and 1.5 miles, for \$780,000; Boggie Creek Rd for 1989 and Old Ree Road for 1990.

ITEM 6 PHILLIP BAKER'S ROAD

DISCUSSION: Mr. Keplin explained to the Transportation Committee members that the Bureau cannot fix a dead-end road, it will have to be a through route, and it was not possible to build a new road to Mr. Baker's place which is 1 1/2 miles off the main highway.
