Bernard said a feasibility study will have to be done first on the Fort Berthold Reservation before the Barness Organization will even consider sponsoring a Bingo Parlor Project and partnership. Mr. Kahrahrah gave some background on the Bectal Corporation and their interest in joint-ventures with tribes. If there is a project that can be done with a tribe on a reservation, the Bectal Corp. will come up and take a look and if they like what they see, they will do or pay for the feasibility study, and then come to a working agreement with the tribe. There was no action taken, as Bectal is aware of the situation.
