Business Council, requesting an additional \$120,000 over and  
above the current Law and Order Budget, and for an additional  
staff of four uniformed police officers for the Fort Berthold  
Reservation.

VOTE: Four (4) in favor, one (1) not voting, motion carried.

ITEM 5 SEPARATION OF POWERS

MOTION NO. 3 - Moved by Tillie Walker, seconded by Ernest Stone  
to have Ken Deane Jr., Tribal Planner, prepare a proposal on  
Separation of Powers to add staff to the court system to develop  
a plan for Separation of Powers.

VOTE: Unanimous, motion carried.
