ITEM GRETA WHITE CALFE - FARM LEASE

> MOTION NO. 2 - Moved by Gordon Blake, seconded by Edmund White Bear to approve the farm lease for 40 Acres of farmground at \$21

an acre for Allotment #1758 for a five (5) year lease.

VOTE: Unanimous, motion carried.

ITEM 6 LAND EXCHANGES

MOTION NO. 3 - Moved by Gordon Blake, seconded by Edmund White Bear to disapprove the land exchange request by Marie Young Bear because of the 1/4 mile buffer zone policy.

VOTE: Unanimous, motion carried.

<u>MOTION NO. 4</u> - Moved by Gordon Blake, seconded by Edmund White Bear to disapprove the land exchange request by Claudia Mason because of the development on the land she is requesting and the 1/4 mile buffer zone.

The Donna Kruger land exchange request will be tabled until Ms. Kruger can look at the tribal land available in the White Shield area.

MOTION NO. 5 - Moved by Gordon Blake, seconded by Edmund White Bear to approve, for a 'Letter of Intent' for appraisals, the land exchange request by Albert Little Owl with the Three Affiliated Tribes, value for value.

MOTION NO. 6 - Moved by Gordon Blake, seconded by Edmund White Bear to approve the land exchange request by James Johnson with the Three Affiliated Tribes, for a 'Letter of Intent' for appraisals.

VOTE: Unanimous, motion carried.

MOTION NO. 7 - Moved by Edmund White Bear, seconded by Gordon Blake to approve, for a 'Letter of Intent' for appraisals, the land exchange request by Celina Mossett with the Three Affiliated Tribes.

VOTE: Unanimous, motion carried.

MOTION NO. 8 - Moved by Gordon Blake, seconded by Edmund White Bear to approve the land exchange request by Holly Fox for a land exchange with the Three Affiliated Tribes, for a 'Letter of Intent' for the purposes of appraisals.

MOTION NO. 10 - Moved by Gordon Blake, seconded by Edmund White Bear to approve, for Lonnie Spotted Bear, farm lease for five (5) years beginning January 1, 1986 and ending December 31, 1990 on T1601 W1/2NW1/4 22-147-91, 80 Acres at \$14.00 per cultivated acre.

MOTION NO. 11 - Moved by Gordon Blake, seconded by Edmund White Bear to approve the modification, for the Billadeau Brothers, that incorporates fifty (50) acres of pastureland into the lease 10 acres owned by George Lewis Jr. 40 acres owned by the Three Affiliated Tribes and increases the annual rental rate by \$150 per year and all other terms and stipulations will remain the same.

ITEM 15 KEITH AND THERESA PRICE - LAND SALE

MOTION NO. 15 - Moved by John Charging, seconded by Gordon Blake to approve the purchase of the two tracts of land that Theresa Price has offered the Three Affiliated Tribes as described below, to be purchased on deferred payment of up to three (3) years with the first payment coming out of the set-aside money and the second and third payment will be paid with the Land Purchase Docket 350G 1987 and 1988 Monies. Kieth and Theresa Price have offered to pay for a BIA recognized appraisor in order to complete the land sale expeditiously.

LAND DESCRIPTION: Allotment 184A SW1/4SW1/4, 15-148-89 40.00 Acres at \$16,000 and Allotment $323A \text{ SW}1/4\text{NW}1/4 26-150-90 120.00 Acres}$ valued at \$48,000.

REMARKS: The Natural Resources Committee requested the Tribal Chairperson, Alyce Spotted Bear, to call United Sioux Tribes for Clarence Sky to expedite the appraisals on these two tracts of land and to call Laura Wingers, GMAC Representative, to inform GMAC of the land purchase.

VOTE: Unanimous, motion carried.
