The meeting adjourned at 12:20 A.M.

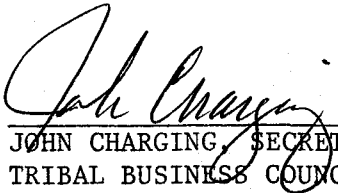
