ITEM 1 CALL TO ORDER

The meeting was called to order at 1:09 P.M.

ITEM 2 ROLL CALL

Roll was called; quorum present (All Members present).

ITEM 3 MARCH AND APRIL STATISTICAL REPORTS FROM TRIBAL COURT

MOTION NO. 1 - Moved by Don Malnourie, seconded by Pete Coffey to approve the March and April Tribal Court Statistical Reports submitted by the Tribal Court Administrator, Joletta Bird Bear.

VOTE: Unanimous, motion carried.

ITEM 4 MOTOR VEHICLE - ABANDON VEHICLES

MOTION NO. 2 - Moved by Don Malnourie, seconded by Ernest Stone to have the penalty of abandoning vehicles on public or private property, not to exceed \$100 as a maximum fine.

VOTE: Three (3) in favor, one (1) abstaining, motion carried.

MOTION NO. 3 - Moved by Pete Coffey, seconded by Don Malnourie to refer this matter to the Full Tribal Business Council, with the recommendation for approval from the Judicial Committee.

VOTE: Unanimous, motion carried.

ITEM 5 SERVING LIQUOR TO MINORS IN LIQUOR ESTABLISHMENTS

MOTION NO. 4 - Moved by Tillie Walker, seconded by Don Malnourie to send a letter of warning to the proprietor of the S&L Bar, regarding serving liquor to minors, with the Judicial Committee Chairman's signature on the letter.

REMARKS: The first incident involving minors being served in a liquor establishment will constitute a letter of warning; the second incident will require a fee to be assessed; the third incident will cause the Tribal Liquor License to be revoked; and the fourth incident will require the State Liquor License to be revoked.


VOTE: Unanimous, motion carried.


