MOTION NO. 5 - Moved by Pete Coffey, seconded by Edmund White Bear to approve the request of Morgan Fettig to rescind the resolution, regarding the Morgan Fettig land exchange with the Three Affiliated Tribes, because Morgan didn't know that this land was right below the buffalo pasture; and to refer this to the Full Tribal Business Council.

VOTE: Three (3) in favor, one (1) abstaining, motion carried.
