ITEM 8 ADJOURNMENT

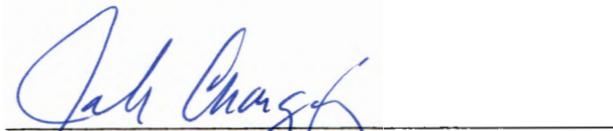
