ITEM 1 CALL TO ORDER

The meeting was called to order at 1:15 P.M.

ITEM 2 ROLL CALL

Acting Secretary, Charging, called roll; quorum present (3 Members present with Coffey sitting in to make up the quorum).

ITEM 3 LAND SALE - BARBARA PRICE FEZLER AND DARRYL PRICE

MOTION NO. 1 - Moved by John Charging, seconded by Edmund White Bear to approve the purchase of land from Barbara Fezler for a cash consideration of \$26,887.45, and by Darryl Price for a cash consideration of \$26,887.45, by resolutions, to be referred to the full Tribal Business Council.

VOTE: Unanimous, motion carried.

ITEM 4 LAND SALE - MARTHA LONE BEAR

MOTION NO. 2 - Moved by Pete Coffey, seconded by Edmund White Bear to approve the purchase of land from Martha Lone Bear for a cash consideration of \$10,000; Arvella White for a cash consideration of \$1,666.67; Bernadine Young Bird for a cash consideration of \$1,666.67; Benjamin Lone Bear for a cash consideration of \$1,666.67; Benita Lone Bear for a cash consideration of \$1,666.67; and Janice Lone Bear for a cash consideration of \$1,666.67; all for #1951 NE1/4, 20-147-91 by resolutions, to be referred to the Full Tribal Business Council.

REMARKS: The Tribe will purchase the Martha Lone Bear (et al) land with the understanding, the Tribe will pay \$125 per acre if the minerals are included in all the shares.

ITEM 5 LAND EXCHANGE - EDWARD SOLLY DANKS & GEORGIANNA DANKS

MOTION NO. 3 - Moved by John Charging, seconded by Edmund White Bear to approve the land exchange request by Edward S. Danks and Georgianna Danks with the Three Affiliated Tribes as described below, by resolution to be referred to the Full Tribal Business Council.

LAND DESCRIPTION: Mr. & Mrs. Danks: #2097 W1/2 16-148-94; #1093A SE1/4SE1/4, 36-151-95 for a Total of 200 Acres Valued at \$29.320.00. Three Affiliated Tribes: #1981 NW1/4 21-151-94; #821A N1/2NW1/4, 9-151-94; #607A E1/2, 29-152-94 for a Total of 246.09 Acres Valued at \$29,320.81.

VOTE: Three (3) in favor, one (1) opposed, motion carried.

ITEM 6 RIGHT-OF-WAYS - MCKENZIE ELECTRIC COMPANY
