ITEM 3 APPROVAL OF MINUTES

Edmund White Bear made a motion to approve minutes for March 24 & 27, 1987, moved to approve by Ernest Stone, seconded by Ted Lone Fight III.

Discussion: Ken Deane said the bill for the rental of the helicopter was paid. Ray Keplin said that he had talked with Mercer County Commissioner, and he is willing to work on Ike Price's road from the county up to the reservation line. Ray said BIA Roads can't go into private own road because of rules and regulations. Ted asked Ray if he know anything about an easement between Warren Wolf and Jim Brugh. Warren Wolf said he thinks they had an easement signed, but could not find it, now he can't get to his land cause Jim Brugh put a no trespassing sign up at the road. Ted asked Ray to check into the easement and let him know. Edmund asked Ray if they could build a approach for Gertrude Sillitti, Ray said they can't cause the road was on county and not BIA. Ray said you have to get a permit by writing the county before anything can be done. The BIA did build an approach for them, but they exchanged their land to the of the fence. Ed Hall wanted to know if the Full Council was going to pick for a Secretary for his department. Barbara Couture has been appointed for thirty days, and Ed Hall would like to get something done before her thirty days are up. Edmund will check into this and let Ed Hall know.
