Doreen Lone Fight requested the Tribe pay KMHA for \$4,137.21 since KMHA paid back taxes for 1984. Edmund White Bear entertained a motion to pay KMHA \$4,137.21, seconded by Ernest Stone. Joe Henry (sitting in at 11:37 a.m.)

VOTE: Three in Favor, Two Opposed, motion carried.

ITEM 7 IRS TAXES-GERALD WHITE

Hugh Baker made a motion to pay Gerald White's taxes of \$3,487.86, seconded by Elgin Crows Breast.

VOTE: Unanimous-motion carried.

ITEM 8 COMMODITIES PROPOSAL (1988)

Hugh Baker moved to approve proposal for commodities, seconded by Ted Lone Fight III.

VOTE: Three in Favor, Two Opposed, motion carried.

ITEM 9 MAHTO BAY ACCESS ROAD AGREEMENT

Hugh Baker made a motion that each cabin owner at Mahto Bay pay \$400.00 per year with a five (5) years lease agreement with option for renewal at the end of five (5) years, which will take effect as soon as the lease is signed. Cabin owners will have to pay the additional \$237.50 and the lease agreement will be revoked if violated by cabin owners, seconded by Delvin Driver.

Discussion: Elgin Crows Breast wanted to know what happens if more cabins were to go up at Mahto Bay? Allen said the limit was twenty (20) cabins, which there was already twenty (20) cabins at Mahto Bay. Hugh directed Allen to see that BIA roads put cattle guard in at Mahto Bay and also maintain the road. Amy Henry (sitting in at 11:45 a.m.)

Albert White Calf is requesting salary of \$4,408.00 when he was employeed by the Four Bears Motor Lodge. Luther Grinnell (sitting in at 12:37 p.m.) Elgin Crows Breast made a motion to hold off paying bills for the Four Bears Motor Lodge, until Tribe's attorney Ray Cross get back to the Council on his findings, and the Council will let Albert White Calf know if they are going to pay him or not, seconded by Delvin Driver.
