ITEM 1 CALL TO ORDER

Meeting called to order at 4:01 p.m.

TTEM 2 ROLL CALL
Roll called by Secretary Lone Fight, quorum
present. For the record Judy Black Hawk recording
secretary called Hugh Baker, Treasurer and notified
him of the meeting and also made an attempt to
contact Elgin Crows Breast, but failed.

ITEM 3 CO-SIGNING OF LOAN FOR GLORIA FAST DOG
Delvin Driver moved to approve Jim Mossett to cosign for Gloria Fast Dog on \$1,000.00 loan based on
his salary and IIM income, seconded by Jim Mossett.

Discussion: Jim Mossett said Gloria Fast Dog needs the loan for medical emergency.

VOTE: Unanimous-motion carried.

ITEM 4 FORT BERTHOLD HOUSING AUTHORITY FORCE ACCOUNT
Ted Lone Fight III moved to pledge \$42,520.00 as
required by U.S. Department of Housing Urban
Development (HUD) from their IIM account, # S-541,
seconded by Delvin Driver.

Discussion: Elgin Crows Breast asked if the Tribe will have to pay for any overruns? Steve Francis said if there was an overrun of \$100,000.00 the Tribe would have to pay for it which in this case Jean Hall is saying there maybe little or no overruns at all. Jean Hall said the Board of Commissioners will be meeting with Ed Hall this coming Friday, and would like the Council to sit in on this meeting.

ITEM 4 FORT BERTHOLD HOUSING FORCE ACCOUNT CONT.

Jean Hall said Ed Hall has worked on force accounts before and he has some good ideas. increase for the Tribal Business Office staff to be
retroactive to October 1, 1987, seconded by Edmund
White Bear.

Discussion: Ed Lone Fight asked for an increase for Cheryl White. Steve Francis said he did not believe the Indirect Pool could take an increase at this time, but if Indirect could take an increase Cheryl White can get an increase.

VOTE: Unanimous-motion carried.
