- ITEM 1 CALL TO ORDER Meeting called to order at 1:30 p.m.
- ITEM 2 ROLL CALL Roll called by Secretary Lone Fight III, quorum present.
- ITEM 3 EF HUTTON & DEAN WITTER Tribe invited EF Hutton and Dean Witter representives regarding investment plans. Tribe is planning on investing their monies, because of low interest rates. (Leo Cummings sitting in at 2:46) Hugh Baker said he was not going to make any committments until he talks with Steve Francis and Ray Cross.
- ITEM 4 LAW ENFORCEMENT CRIMIAL CODE Discussion: Homer White Buffalo said Law Enforcement Criminal Code is requesting changes of policies. Tribal Court can take jurisdiction over major crimes. Homer White Buffalo said no action was needed today. Hugh Baker suggested that Homer White Buffalo draft up a resolution and a letter requesting more funds for more manpower.
- ITEM 5 CURFEW ORDINANCE Hugh Baker entertained a motion to change the curfew ordinance reservation wide to 16 years old and requesting time change to 10:00 p.m. Moved to approve by Elgin Crows Breast, seconded by Delvin Driver.
