Regular Meeting September 30, 1987

ITEM 1 CALL TO ORDER

Meeting called to order at 10:30 a.m.

ITEM 2 ROLL CALL
Roll called by Secretary Driver, quorum present.

# PANGE UNIT 206 Discussion: Hugh Baker asked Rich Schilf if he contacted Dennis Huber about todays meeting? Rich Schilf said he talked with Dennis Huber but he cannot be here today. Kingden Black Hawk said someone should be at the range unit when Dennis Huber moves his cattle out. Dennis Huber moves his cattle out anytime of the day or night. Kindgen Black Hawk said Dennis Huber has branded a couple of his calves and also has taken some of his cows up to Twin Buttes. Requesting someone to check Dennis Huber's cattle when he is moving them out. Tabled: BIA Range requested to be at meeting. (Daryl Price sitting in at 10:46 a.m.)

# ITEM 4 LAND SALE/MARTHA FREDERICKS

Rich Schilf recommened to the Committee to go over land purchases and move the ones that qualify to FmHA to free up docket funds. Hugh Baker entertained a motion to support Rich Schilf's recommendation and try to free up docket funds so that the Tribe can purchase land that does not qualify for FmHA. Moved to approve by Delvin Driver, seconded by Ted Lone Fight III.

Discussion: It was directed by the Committee for Texx Lone Bear to do a route sheet on Martha Fredericks for the next committee meeting.

ITEM 5 LAND EXCHANGE/ALONZO PHELAN
Hugh Baker entertained a motion to approve letter of intent for land
exchange for Alonzo Phelan. Moved to approve by Ted Lone Fight III,
seconded by Delvin Driver.

# ITEM 6 LAND EXCHANGE/ARDIS FAYE DRIVER

Hugh Baker entertained a motion to approve a letter of intent on the land exchange for Ardis Faye Driver. Moved to approve by Ted Lone Fight III, seconded by Delvin Driver.

Delvin Driver moved to tabled land exchange because Paul Driver was planning on exchange his land for the requested exchange, seconded by Ted Lone Fight III. (Don Stroud and Tom Hilken BIA Range sitting in at 11:15 a.m.)

# ITEM 8 RANGE UNIT 206

Hugh Baker asked Don Stroud if he documents any of the complaints he received from Kingden Black Hawk? Don Stroud said they do not document any in coming complaints unless they were in writing. Hugh Baker asked if BIA Range made sure that cattle are moved during daylight hours as stated in Resolution No. 86-42-C. BIA Range does not have the a copy the resolution. BIA will meet with Homer White Buffalo, Natural Resource and to try and enforce language on resolution. Can you modify permits so language can be put into the permits stating that cattle be moved only during daylight hours, and also to let BIA Range and Natural Resource Department know that cattle will be moved. Don Stroud said the only time they can modify a permit is if the leasee agrees. Rich Schilf will do a resolution with amendments to language to resolution 86-42-C. Leasee will notify BIA Range and Natural Resources of moving cattle off reservation and segement to segments, moved to approve by Ted Lone Fight III, seconded by Delvin Driver.

Discussion: Hugh Baker told Rich Schilf to contact Dennis Huber and let him know that Tribal Rangers will be down when he moves his cattle. (Chip White and Dennis Conklin sitting in at 11:31 a.m.)

VOTE: Unanimous-motion carried.

Hugh Baker entertained a motion for Rich Schilf to proceed to get Tribal Rangers to be brand inspectors. Moved to approve by Ted Lone Fight III, seconded Delvin Driver.

Hugh Baker entertained a motion to purchase Barbara Price Frezler
and Daryl Price's land using FmHA funds. (see attachments) Moved to
approve by Ted Lone Fight III, seconded by Delvin Driver. (Ed Lone
Fight sitting in at 1:22 p.m.)

VOTE: Unanimous-motion carried.

### ITEM 17 PROCLAMATION SMALL GAME

Ray Cross said you should limit to trust lands only on the proclamation for non-members hunting. Rich Schilf said they got \$34,000.00 additional funds for the Game and Fish Department. Ted Lone Fight III moved to approve memorandum regarding non-memmber hunting on Fort Berthold, seconded by Delvin Driver. (Ken Fredericks Sr and Ken Fredericks Jr sitting in at 1:29 p.m.)

VOTE: Unanimous-motion carried.

### ITEM 18 TRIBAL RANGERS

Chip White and Dennis Conklin asked the Committee what they should do with non-members hunting on the Reservation? Hugh Baker said the Tribe has jurisdiction over non-members so cite them and file it in Tribal Court. It was directed by the Committee for Rich Schilf to set up a workshop with Homer White Buffola, Ray Cross and Tribal Rangers.

ITEM 19 CONSULTANT AGREEMENT/KEN FREDERICKS SR
Hugh Baker entertained a motion to hire Ken Fredericks Sr to work on
Farm Credit Program starting Oct. 1 to Oct. 30, 1981. Moved to
approve by Ted Lone Fight III, seconded by Delvin Driver.

VOTE: Unanimous-motion carried.

### ITEM 20 KEN CHARGING

Hugh Baker entertained a motion to approve Ken Charging's fee patent request. moved to approve by Delvin, seconded by Ted Lone Fight III.

VOTE: Unanimous-motion carried.

### ITEM 21 MEETING

A Meeting will be scheduled for October 14, 1987 during Natural Resource Committee with FmHA and BIA apprasials to discuss capitalization.

### ITEM 22 FEE PATENT REQUEST

Delvin Driver moved that Rich Schilf develop a resolution so tribal members can transfer their lots back into trust for tomorrows meeting, seconded by Ted Lone Fight III.

ITEM 23 RANGE LEASING POLICIES

Hugh Baker entertained a motion to sublease at 100% for ranchers. Moved to approve by Delvin Driver, seconded by Ted Lone Fight III.

Discussion: Hugh Baker directed Rich Schilf to let the leasee know that the subleasing was just for one year at 100%.
