- ITEM 1 CALL TO ORDER

 Meeting called to order at 11:30 p.m.
- ITEM 2 ROLL CALL
 Roll called by Secretary Driver, quorum present.
- ITEM 3 FMHA LAND PURCHASE
 Hugh Baker entertained a motion to recommend land purchases to Full
 Council to move lands that are eligible to FMHA, so docket funds can
 be freed to purchase other lands. Moved to approve by Delvin Driver,
 seconded by Jim Mossett.

VOTE: Unanimous-motion carried.

- ITEM 4 LAND SALE/MARTHA FREDERICKS

 Texx Lone Bear said that Martha Fredericks' land was low in rating.

 Hugh Baker requested Texx Lone Bear to prioritize Martha Fredericks' land sale and bring it back to the next NRD Meeting on October 20, 1987.
- TTEM 5 SANISH LOTS
 Hugh Baker entertained a motion to explore the option to purchase the lots at Sanish and Natural Resource Department will find out the appraisal cost. Moved to approve by Delvin, seconded by Jim Mossett.

Discussion: Jean Krenz said she paid for the first appraisal and would like the Tribe to request the appraisal this time. Hugh Baker said that Tribe would have to request another appraisal, but can not use the Bureau they will not do appraisals on fee land. (Arine Guimont and Dr. Spang sitting in at 11:50 a.m.)

ITEM 6 BUSINESS DEVELOPMENT LEASE

Hugh Baker entertained a motion to approve a Business Development Lease of 2 1/2 acres to Glen Yellow Bird in White Shield near the Powwow grounds. Moved to approve by Delvin Driver, seconded by Jim Mossett.

Discussion: Rich Schilf said he would have to request a survey.

ITEM 7 FARM LEASE/GEORGIANN DANKS

Discussion: Sollie Danks asked Dr. Spang why his wife was excluded from getting any money from her farm lease? Dr. Spang told Sollie Danks that the Bureau was taking position that in owner's use the owner will not be entitled to benefits. Dr. Spang said this was under appeal and Mr. Danks can continue the appeal so he will not comment on this anymore. Hugh Baker suggest that Sollie Danks proceed with the appeal.

Discussion: Rich Schilf said Ralph Little Owl is in need of the money for Mahto Bay, but Joe Chase will not sign. Jim Mossett asked Dr. Spang if he could sign for Joe Chase? Dr. Spang said he had no authority to sign for Joe Chase. The Cabin owners will not sign the lease until all the land owners sign. Jim Mossett will work with Joe Chase.

Hugh Baker entertained a motion to authorize Tex Barnes to develop a proposal for car crushing. Moved to approve by Delvin Driver, seconded by Jim Mossett.

Discussion: Hugh Baker suggest that Tex Barnes work with Housing, Hud and the State with his car crushing proposal.

VOTE: Unanimous-motion carried.
