Regular Meeting October 8, 1987

TTEM 1 CALL TO ORDER

Meeting called to order at 8:54 a.m.

ROLL CALL Roll called by Acting Secretary Crows Breast, quorum present.

ITEM 3 LEGAL DEPARTMENT

Hugh Baker moved that Ray Cross send a letter to Secretary Doyle to speed things up on returning of trust lands, seconded by Delvin Driver. (Ted Lone Fight III joined the meeting at 9:05 a.m.)

VOTE: Unanimous-motion carried.

Hugh Baker moved that the Legal Department darft a bill to be passed during the November 17, 1987 meeting in Washington D.C., seconded by Delvin Driver. (Ron Ryan, Jean Hall, and Theola Fox sitting in at 9:13 a.m.)

VOTE: Unanimous-motion carried.

TTEM 4 RETURN TO TRUST LOTS

Discussion: Dr. Spang said enrolled members are requesting their lots in New Town and Parshall to be put back into trust. Dr. Spang said in order for the members to return their lots back to trust, all the taxes should be paid up. Dr. Spang said that once the lots are back into trust, the city will not provide services such as sewage, trash pickup, and whatever services they are receiving now. Dr. Spang said he would send a memo over for Ray Cross to review on the return of trust lots.

Discussion: Hugh Baker said Ed Lone Fight and himself have been visiting with the local banks and also the banks in Minot. Hugh Baker said they invited some of the board members from Fist American State Bank. The Tribe may go with First American State Bank if they decide to invest the docket funds.

Discussion: Ahmed Koores will be doing some checking with Mckenzie and Mountrail electric companys to see if they have a contract with the Tribes.

## ITEM 7 FORT BERTHOLD HOUSING AUTHORITY

Hugh Baker moved to approve that the Tribe support Fort Berthold Housing Authority to collect delinquent rent from all tribal employees by payroll deductions if agreed upon by the employee, seconded by Edmund White Bear.

Discussion: Hugh Baker said that Fort Berthold Housing Authority has alot of delinquent rentors, and in order for Fort Berthold Housing to get more mutual homes or rentals they would have to try and collect the delinquent rent. Jean Hall said in order for the people to be eligible for mutual homes or rentals they would have to pay up their delinquent rent first. Elgin Crows Breast said even if the people are working they sometimes do not have the money to pay their rent and pay other bills due to the high rent rate. Edmund White Bear said H.U.D should do something in lowering the rent, because some of the Tribal members on living on a set income.

VOTE: Unanimous-motion carried. Resolution No. 87-189-TL

Ted Lone Fight III moved to approve that the Tribe support Fort Berthold Housing Authority in collecting delinquent rent from I.H.S. and Bureau of Indian Affairs employees by payroll deductions if agreed upon by the employee, seconded by Jim Mossett.

#### ITEM 12 ULITITY COMMISSION

Hugh Baker moved to refer the Lagoon near Four Bears back to I.H.S. will need to know the operating, maintenance and training cost, seconded by Delvin Driver.

VOTE: Unanimous-motion carried.

Jim Mossett moved that I.H.S. assist Twin Buttes in getting funding for a Lagoon, seconded by Delvin Driver

VOTE: Unanimous-motion carried.

Hugh Baker moved to approve travel for Jim Mossett and Elgin Crows Breast to attend the Water Commission meeting in Sioux City, Iowa on October 26-30, seconded by Delvin Driver.

Discussion: I.H.S. will reimburse the Tribe for two people and will pay mileage for one car.
