Regular Meeting
October 9, 1987

- PRESENT: Edmund White Bear, Chairman; Jim Mossett, Acting Secretary, Elgin Crows Breast, and Hugh Baker, sitting in.
- ABSENT : Ted Lone Fight III.
- OTHERS : Ed Hall, Transportation; Paige Baker, Reservation Programs; and Judy Black Hawk, Recording Secretary.
- ITEM 1 CALL TO ORDER
Meeting called to order at 4:03 p.m.
- ITEM 2 ROLL CALL
Roll called by Acting Secretary Mossett, quorum present.
- ITEM 3 BLADING OF SCHOOL ROADS
Hugh Baker made a motion to appoint Ed Hall to work on a plan in cooperation with the Bureau of Indian Affairs on the blading of the roads, also will be in charge of getting all school bus routes form all the schools, seconded by Jim Mossett.
- Discussion: Edmund White Bear will work with Leo Cummings in getting a positions from JTPA, and Transportation will match the funds. Edmund White Bear said we would have to get easements, before we even starting blading. Edmund White Bear asked Paige Baker if there was gravel on the east side of town? Paige Baker said he will check, and get back to Edmund White Bear.
- VOTE: Unanimous-motion carried.
- ITEM 4 PUTTING SEGMENTS INTO SEQUENCES
Jim Mossett made a motion to put the segments into sequences today, starting with Twin Buttes because it is the furthest and has the worst roads, and then go to White Shield, Parshall, Shell Creek, Four Bears, and Mandaree. No second motion dies.
- Hugh Baker made a motion to start with Shell Creek, Four Bears, Mandaree, Twin Buttes, White Shield and Lucky Mound due to economic and geography reasons this will be for blading of the school bus routes only, seconded by Elgin Crows Breast.
- VOTE: Three in Favor, One Opposed, Motion carried.
- ITEM 5 WAIVER OF PERSONNAL POLICIES
Jim Mossett moved to waive the Personnel Policies to hire two operators due to the emergency and appointed Ed Hall to hire for the two operators. Seconded by Hugh Baker.
- VOTE: Unanimous-motion carried.
