ITEM 1 CALL TO ORDER

Meeting called to order at 12:00 noon.

ITEM 2 ROLL CALL
Roll called by Secretary Driver, quorum present.

ITEM 3 MINERALS SALE/ROXY CUTLER
Hugh Baker entertained a motion to purchase Roxy Cutler's minerals
with docket funds at appraised value, and Natural Resource
Department will write a letter of intent. Moved to approve by Elgin
Crows Breast, seconded by Delvin Driver.

VOTE: Unanimous-motion carried.

ITEM 4 JOB SERVICES

Discussion: Ivetta Spotted Bear said they were inquiring on getting a trailer house for Job Services, and she would like the trailer house near the Tribal Building so the people would not have far to get to their office. Jim Foote said if Job Services gets the trailer house he would like to move his CHR's into that trailer, and Ivetta Spotted Bear can move her office into the WIC office, and WIC could move into Jim Foote's office, so the Human Resource Department will be in one office. Hugh Baker said Jim Foote should inquire about the trailer house. Ivetta Spotted Bear said they were working on possible paying the rent for next year.

ITEM 5 LEASING OF GRAVEL PIT
Discussion: Keith Mandan would like to lease the gravel pit near
the pow-wow grounds. Hugh Baker said that was corp land, and maybe
Keith Mandan could look at another gravel pit to lease.

ITEM 6 LAND PURCHASES

Hugh Baker entertained a motion to approve the purchases of land sales from Leo Standish, Herman Young Bird and Leota White.

Discussion: Hugh Baker said the Tribe will purchase \$2,147.00 of Leota White's shares, and if she wants to sell more to the tribe she may.

ITEM 7 LAND PURCHASE/JOE CHASE JR

Tabled - until the appraisals are ready for committee review.

ITEM 8 FARM LEASE Hugh Baker entertained a motion to approve 125A farm lease at \$25.00 dallors an acre to Wade Williamson for four (4) years, Wade Williamson will not take a cut from the harvest crop. Moved to approve by Delvin Driver, seconded by Elgin Crows Breast.

VOTE: Unanimous-motion carried.

Dicussion: Rich Schilf said he did some checking on Vernon Sitting Crow's farm lease T583A which was approved by the committee last week. Rich Schilf said that Vernon Sitting Crows does not own any cattle but Emery Good Bird takes 1/3 of the alfalfa and a non-indian takes the other 3/4 of the alfalfa. Ed Hall would like to lease T583A. Hugh Baker said maybe Vernon Sitting Crow and Ed Hall could work something out.

ITEM 10 SKUNK CREEK BAY ACCESS

Hugh Baker entertained a motion to approve the Skunk Creek Bay
Access lease modification. Moved to approve by Elgin Crows Breast,
seconded by Delvin Driver.

VOTE: Unanimous-motion carried.

TTEM 11 LAND ADVERTISMENT

Hugh Baker entertained a motion to inquire on the land advertisement by LBM near the reservation the tribe may be able to purchase the land. Moved to approve by Delvin Driver, seconded by Elgin Crows Breast.

Discussion: Hugh Baker directed Rich Schilf to check to see who purchased the land near Anton Fettig's and see if there was a way to upset the land sale. Hugh Baker also directed Rich Schilf to get copies of all up coming land sales from the county commissioner's office. It was directed for Rich Schilf to contact the State Water Commissioner and let him know that the Tribe did not give anybody permission to do a study on the water system.

VOTE: Unanimous-motion carried.
