- ITEM 1 CALL TO ORDER Meeting called to order at 2:05 p.m.
- ITEM 2 ROLL CALL Roll called by Secretary Lone Fight III, guorum present.
- ITEM 3 TITLE III Discussion: Ed Lone Fight asked Larry Brewster if the State would be able to forgive the Tribe for the money owned to Title III? Larry, Brewster said no they can not, but can work out some type of payment plan with the Tribe. The State is be willing to nogiate with the Tribe, so the Tribe can pay the money back. Larry Brewster said he made a visit with the Parshall Senior Citizen's Program and he will work with Delvin Driver in funding the Senior Citizens' of Parshall. (Ronnie Rabbit Head sitting in at 2:22 p.m.) Larry Brewster said if the Tribe receives Title IV funds you will not be able to receive Title III funds. (Ted Bolman sitting in at 2:29 p.m.) Recommendation for the Senior Citizen's building is to include the handicap materials in the bathroom, and the sidewalk, and more room is needed in the kitchen to move around, also more storeage space. Ray Cross said he would do some checking into the Title III situtation.
