- ITEM 1 CALL TO ORDER Meeting called to order at 11:07 a.m.
- ITEM 2 ROLL CALL Roll called by Secretary Lone Fight III, quorum present.
- ITEM 3 638 CONTRACT/IHS Discussion: Dick Bad Moccasin requested the language be changed on Resolution No. 88-25-TL in order for the Area. Office to accept the Resolution, Dick Bad Moccasin said change "positions to programs". Hugh Baker moved to make the necessary language amendments to Resolution No. 88-25-TL, seconded by Ted Lone Fight III.

VOTE: Four in Favor, One Not Voting, One Opposed, Motion Carried.

ITEM 4 WAIVER OF ONE-HALF OF CORPORATION CREDIT LOAN Hugh Baker moved to waive one-half of Marie Wells' corporation credit loan due to medical reasons, seconded by Elgin Crows Breast.

Tex Wounded Face said he was working on developing a Native American Hall of Fame, and Richard Crows Heart Jr., has been working with him in identifying the talent of the tribal members in art.

ITEM 8 LAND SALE/JOE CHASE JR Hugh Baker moved to purchase forty (40) acres of Joe Chase Jr's 240 acres with docket funds and purchase the remaining 200 acres with FmHA funds, seconded by Delvin Driver.

ITEM 9 MYRTLE FOX Hugh Baker moved to approve a \$300.00 loan to Myrtle Fox for medical reason, seconded by Delvin Driver.

Discussion: The \$300.00 will be taken from T2 account misc., and Hugh Baker will work on a repayment schedule for Myrtle Fox.

> Discussion: Ed Lone Fight said once the JTAC bill is presented the Tribe needs all the support it can get, so the Tribe does need someone like Jim Danks to work with the non-Indians.

## ITEM 13 STANDING ROCK SIOUX TRIBE Hugh Baker moved that this Tribe proceed with just one bill for JTAC which does not include Standing Rock Sioux Tribe, seconded by Elgin Crows Breast.

Discussion: Ed Lone Fight said he received a call from Allen White Lighting and he was requesting that the Standing Rock Sioux Tribe and the Three Affiliated Tribes get together and present one bill for JTAC. The Councilmember's were not in favor of this. Ed Lone Fight said Allen White Lighting also wanted to hire Lee Foley, but this will be left up to Lee Foley. Ray Cross said Lee Foley already turned them down.

VOTE: Unanimous-motion carried.

ITEM 14 BUREAU OF RECLAMATION

> Discussion: Ray Cross said Bureau of Reclamation was asking questions regarding the rehabilitation of the Mandaree and Twin Buttes' water system? Bureaw of Reclamation is wondering if they would be responsible for the pumps once they are rehabilitated. Ted Lone Fight III said that the Tribe cannot be responsible financially. Hugh Baker moved to write a letter to Bureau of Reclamaiton regarding the rehabilitation of the water pumps for Mandaree and Twin Buttes.

VOTE: Unanimous-motion carried.

- MANDAREE SCHOOL BOARD/TWIN BUTTES SCHOOL BOARD Discussion: Ed Lone Fight said he received a call from Dennis Fox regarding the Mandaree School Board and Twin Buttes School Board members and Administrators from these two schools. Dennis Fox told Ed Lone Fight that the school board members and superintendents were in his office requesting them to rescind the one year contract resolution that was passed by the Council. Dennis Fox told the school board members and administrators that the Tribal Council has authority to pass resolutions and set limitation on the contract and also for them to work with the Tribal Council. Ed Lone Fight said the following School Board Members who went to Washington D.C. are as follows: Evangeline Mandan, Joletta Bird Bear Paul Good Iron, Eugene Holen, and Frank Taylor, Mandaree School Superintendent; Norman Bakke, Adminstrator for Twin Buttes School and Lillian Holen, Administrative Asst. for Twin Buttes School. Ed Lone Fight also received a call from Doug Norell, and he wanted to know what was going on because Paul Good Iron was demanding to meet with Congressmen Byron Dorgan.

ITEM 15 CONT. MANDAREE SCHOOL BOARD

Ed Lone Fight told Doug Novell that the Tribal Council was not going to close Mandaree School down and build a reservation boarding school. The Tribal Council passed a resolution contracting the Mandaree School for one year so the Tribal Council can review the contract every year. This was brought on because of the Mandaree School's audit. Ed Lone Fight said he also received a call from Mary Jo Vren, Select Committee on Indian Affairs; she wanted to know what was going on. Ed Lone Fight said he told Mary Jo Vern the same thing he told Doug Novell. The Tribal Business Council was not in favor of the School Board Members/Administrators going to Washington D.C. and lobbying the Congressmen. This may jeopardize the JTAC bill. Ed Lone Fight said he was calling a public information meeting on February 1, 1988 at the Community Hall in Mandaree at 6:00 p.m. and was inviting the School Board Members.

ITEM 16 TRANSFER OF TRIBAL FUNDS TO FIRST AMERICAN BANK & TRUST Hugh Baker said the Tribal accounts will be closed at Lakeside State Bank after this weeks payroll and transferred to Minot. Steve Francis said two accounts will be left at Lakeside State Bank payroll and the centralized account which will maintain a balance of \$1,000.00. Hugh Baker will sign a letter to that effect to Darold Peterson.

Homer White Buffalo was called into the Meeting at 3:04 p.m. Homer White Buffalo said if there was a warrant for someone then they would give the information to the County officers but they do not allow the outside officers to come into the reservation and take people off the reservation. Hugh Baker moved to have Dr. Alonzo Spang, BIA Superintendent; Homer White Buffalo, Agency Special Officer; Jim Mossett, Tribal Council Member; and Melvin Rabbit Head, Community Chairman to do an investigation on Wendell White, seconded by Elgin Crows Breast.

VOTE: Unanimous-motion carried.

ITEM 19 RECOMMENDATIONS ON IHS SUD Ed Lone Fight entertained a motion to recommended Jim Foote as the IHS Sud. Moved to approve by Delvin Driver, seconded by Elgin Crows Breast.

> Discussion: Ted Lone Fight III said we should get someone else from a different reservation, because a month or two someone is going to request that Jim Foote be removed as IHS Svd. Jim Mossett said I talked to Jim Foote and all he is asking for is a chance, and if the people request him to be removed then the Council will have to remove him.

ITEM 28 EXTENSION OF LEASE PAYMENTS Edmund White moved to request an extension of lease payments for all Indian operators, seconded by Delvin Driver.

Absent: Delvin Driver. Others: Dorreen Yellow Bird, KMHA Director, and Jim Bluestone, Recording Secretary.

ITEM 41 AHEAD OF THE HERD

Discussion: Dorreen Yellow Bird gave a financial condition of the Ahead of the Herd Newspaper. Accounts receivables total report \$3441.89 and accounts payables total \$11,248.60.
