- ITEM 1 CALL TO ORDER

  Meeting called to order at 10:41 a.m.
- ITEM 2 ROLL CALL
  Roll called by Secretary Lone Fight, quorum present.
- ITEM 3 MANDAREE/TWIN BUTTES SCHOOL RESOLUTION
  Hugh Baker moved to approve the Mandaree/Twin Buttes School
  Resolution requesting the Tribe to establish a Tribal
  Education Department and P.L. 93-638 contract the funds for
  the Mandaree/Twin Buttes School, seconded by Ted Lone Fight
  III.

Discussion: Ed Lone Fight said the Tribal Council has the capability to establish an Education Department, at this time the Tribal Council has contracted the Community College which is certified. Hugh Baker said we would like local control over all funds, and if the Tribe lobbies for State funds we would like to control the State funds. (Kip Quale sitting in at 11:02 a.m.) Kip Quale said the Tribal Council does not have to set a three (3) year limitation on the P.L. 93-638 contracts, the Tribal Council has the authority to set limitation on all contracts. Elgin Crows Breast said as school board members you say you are under the state and when you do not agree with something you say you are under the Tribe, I believe that we need to settle this either you are under the Tribe or the State. Elgin Crows Breast said as Indian people we should take control of our education. Ed Lone Fight said the Superintendent in Mandaree is calling all the shots, he hires and fires, also a year does not go by without the Mandaree School in newspapers or community members marching around the school. (Frank Henry 11:26 a.m.) Norman Bakke said for the record he does not hire any of the personnel, the School Board does.

VOTE: Five in Favor, One Opposed, Motion carried. Resolution No. 88-61-TL

  Discussion: Kip Quale said the Tribe will be able to secure favorable opinion from the Attorney General to get a 4% vehicle tax exemption and also gas tax exemption.
- ITEM 6 PURCHASE OF ALCOHOLISM VEHICLE

  Hugh Baker moved to approve Alcoholism to purchase a

  vehicle from Aubol's Inc. since they have a lower bid,
  seconded by Elgin Crows Breast.

Discussion: Joe Roehr said the reason for recommending Aubol's Inc. was because of local services and also they would get a \$500.00 rebate.

VOTE: Unanimous-motion carried.

ITEM 7 ALCOHOLISM COUNSELOR
Elgin Crows Breast moved to hire Georgia Fox as the
alcoholism counselor for the Twin Buttes area, seconded by
Ted Lone Fight III.

Discussion: Jim Mossett said Mandaree already has a counselor, so why not pick someone from Twin Buttes. Joe Roehr felt that the community members would open up to an outsider and not someone from the community. (Hugh Baker called out of the meeting)

VOTE: Three in Favor, Two Opposed, Motion carried.

Edmund White Bear moved that the next Alcohlism counselor position go to White Shield, seconded by Hugh Baker.

VOTE: Unanimous-motion carried.

Hugh Baker moved to re-vote on the hiring of the alcoholism counselor because he was called out of the Meeting, seconded by Jim Mossett.

VOTE: Three in favor, Three Opposed, Motion dies.

will work with them on their salary increases, seconded by
Ted Lone Fight III.

Discussion: Ed Lone Fight said maybe we could hire a physician assistant in Twin Buttes so we can bring up our numbers in order for the Tribe to get a hospital. Hugh Baker said if we get a good administrator in the Human Resource Department we could provide more services to the public.

Salamanca, seconded by Hugh Baker.
