February 21, 1989

PRESENT: Titus Hall, Chairman; Austin Gillette, Secretary; Ed Lone Fight, Member and Ted Lone Fight sitting in.

ITEM 1 CALL TO ORDER
Meeting called to order at 1:05 p.m.

ITEM 2 ROLL CALL
Roll called by Secretary Gillette, quorum present.

ITEM 3 TRAVEL APPROVAL
Ed Lone Fight moved to approve travel for James Johnson and Maynard Fox to attend a PL 99-750 meeting in Denver, Co. on March 7-10, seconded by Austin Gillette.

VOTE: Unanimous-motion carried.

ITEM 4 COMPUTER FOR TRIBAL COURT
Tabled until the next meeting.

ITEM 5 CRIMINAL CODE
Ed Lone Fight moved to approve the revisions to the Tribal Criminal Code for full council action, seconded by Austin Gillette.

VOTE: Unanimous-motion carried.

ITEM 6 EXTRADITION
Ed Lone Fight moved to grant the extradition order on Diane Finley to the State of North Dakota, seconded by Austin Gillette.

VOTE: Two in favor, one opposed, motion carried.

ITEM 7 COMPUTER FOR TRIBAL COURT
Austin Gillette moved to do a broad review of current computers within the Tribal Government and set up a meeting with the IBM office out of Minot, seconded by Ted Lone Fight III. (Ed Lone Fight left the meeting at 1:18 p.m. and Maynard Young Bear joined the meeting.)

VOTE: Unanimous-motion carried.

ITEM 8 PEACE MAKER CODE

Discussion: Luther Grinnell said the peace maker code if passed can be used for family disputes, husband and wife disputes; etc. Luther Grinnell said he held two cases already using the peace maker's code and it worked real well. (Ted Lone Fight III left the meeting at 1:40 p.m. and Hugh Baker called into the meeting) Maynard Fox said a lot of the cases can be taken care of before going to court. Austin Gillette moved to approve the peace maker code for full council action, seconded by Hugh Baker.

VOTE: Unanimous-motion carried.

ITEM 9 IN SERVICE TRAINING

Austin Gillette moved to authorize an in service training for the Child Welfare staff to be provided by Judge Tom Beyer and Legal Services, and Tribal Court will pay Judge Beyer for his services, seconded by Hugh Baker.

Discussion: Diane Johnson will set up the in service training with Judge Beyer and Legal Services.

VOTE: Unanimous-motion carried.

ITEM 10 IMPROVEMENTS OF THE TRIBAL COURT SYSTEM

Austin Gillette moved to authorize a meeting with Judge Beyer and the Full Council on how to improve the Tribal Court System and Tribal Court will pay Judge Beyer for this meeting, seconded by Hugh Baker.

Discussion: Austin Gillette directed Diane Johnson to contact Judge Beyer and ask him if he could draft his purposed changes. Hugh Baker said he would like to meet with Judge Beyer as soon as possible. It was decided by the Committee to put Judge Beyer on the Full Council agenda for March.


VOTE: Unanimous-motion carried.

ITEM 11 ADJOURNMENT


