# Regular Meeting April 12, 1989

ITEM 1 CALL TO ORDER

Meeting called to order at 10:45 a.m.

ITEM 2 ROLL CALL Roll called by Secretary Gillette, quorum present.

ITEM 3 FMHA

Hugh Baker entertained a motion to approve a resolution for full council action that the Tribe, FmHA and BIA together develop programs that would be responsive to new borrowers and existing borrowers to avoid the kinds of situations we have. Moved to approve by Austin Gillette, seconded by Jim Mossett.

Discussion: Lorace Hakansen said 75 applications were mailed out and 47 applications came back but they were incomplete. (Pat Fredericks sitting in at 10:50 a.m.) Hugh Baker said you should have a screening process for the new FmHA clients to see if they qualify agriculturally, and if they don't then you should provide them with some type of training. Lorace Hakansen shared information as to how they process applications for FmHA. Hugh Baker said he would like to talk to Lorace Hakansen about a resolution that the Tribe had passed requesting his removal. Hugh Baker said if he were to change his mind on the resolution, he would need to see some changes at the FmHA office and said the Tribes real concern is the new borrowers. Hugh Baker said I would also like to see Lorace over here once a month. (Gainus Little Soldier sitting in at 11:05 a.m.)

Hugh Baker entertained a motion to approve a timber permit for Pat Fredericks, provided that Natural Resource Department marks the trees. Moved to approve by Jim Mossett, seconded by Austin Gillette.

Hugh Baker said south of the road is corp land. Terry Thorton said by putting in a baseball field there it would be recreational. Hugh Baker said he would go along with giving him a site for a store at the old Community College site. Terry said he would like to put his store south of the road not at the old community college site. Austin Gillette said you can not put a store south of the road because that is corp land, we can give you a grazing lease. Hugh Baker said give us a business plan as to what you are going to develop. Hugh Baker said he would have to present Terry's business plan to the Community.

Discussion: Delvin Foote said Allotment T283A was his
lease but Betty Huesers was given the lease this year.
Myrna Jacobs said the lease was put on the bid lease
because Delvin Foote was cancelled out on this lease.

Hopkins' land with docket funds, seconded by Jim Mossett.

Moran's land with docket funds up to \$2,000 worth,

Discussion: Texx Lone Bear said Curtis Grinnel's land is a good piece of land it is right next to the taken area and he has the whole 300 acres for sale. Hugh Baker said can we use FmHA funds. Rich Schilf said no, it is all grass land. Hugh Baker asked if any of it was tillable? Hugh Baker said if it can be farm, we can give someone a five year lease on it if they can break it. Rich Schilf said he would check to see if he could find anyone to lease it and see if it will qualify for FmHA funds.

Discussion: Texx Lone Bear said Leo Standish wanted to
trade forty (40) acres north of Billy Baker's house.
Hugh Baker wanted to know if there was a problem with the
trade and Texx Lone Bear said no there is no problem with
the trade. Rich Schilf said Ted Lone Fight Jr. has a
problem with it. Austin Gillette said this a 160 acre
tract (100% tribal owned) and why are we going to trade
forty (40) of it. Austin Gillette said he would not go
along with the trade. Hugh Baker said we can give him a
homesite lease. Does not qualify for a trade.

last two (2) years. Moved to approve by Austin Gillette,
seconded by Delvin Driver.

Hugh Baker entertained a motion to approve the 1989
leasing bid advertisement. Moved to approve by Jim
Mossett, seconded by Austin Gillette.

Discussion: Myrna said on #14 she was able to negotiate \$3.50 per acre for grass with Shawn Fredericks; #16 Myrna was also able to negotiate \$3.50 per acre for grass with Lyndon Fredericks. #22 Tom Fredericks will not go \$17.00 pre acre on #22 since it is go back. Austin Gillette said he would not change his position to charge \$4.50 an acre for grass. Hugh Baker said lets change the status on #22 back to tame hay/farm pasture.

Hugh Baker said put Paige Baker and Pat Hemmy on the team Hugh Baker said housing should be on there.

Austin Gillette moved to maintain the farm pasture status to \$3.50 per acre, seconded by Jim Mossett.
