Regular Meeting May 17, 1989

- PRESENT: Hugh Baker, Chairman; Ted Lone Fight III, Acting Secretary; Jim Mossett sitting in.
- ABSENT : Austin Gillette on travel.
- OTHERS : Rich Schilf, Administrator NRD; Mervel Hall; Roszella Little Soldier; Dr. Alonzo T. Spang, BIA Superintendent; and Judy Black Hawk, Recording Secretary.
- ITEM 1 CALL TO ORDER Meeting called to order at 11:25 a.m.
- ITEM 2 ROLL CALL Roll called by Acting Secretary Lone Fight, quorum present.
- ITEM 3 BUREAU OF INDIAN AFFAIRS Discussion: Ted Lone Fight III told Dr. Spang he was not happy with the Bureau's realty program. Ted Lone Fight III felt that the Bureau took too long with the Tribes' request for appraisals, wrong fact sheets, etc. Dr. Spang said since everything has been put on computer there is be no more problems. Hugh Baker said our Natural Resource staff can do the fact sheets and order appraisals. Dr. Spang said he did not see a problem in Natural Resource doing the fact sheets and order appraisals. Hugh Baker said we intent to contract realty.
- ITEM 4 ROSZELLA LITTLE SOLDIER SUB-LEASE Discussion: Roszella Little Soldier said she would like to sub-lease to the Zap recreation board just for one (1) year. Hugh Baker said Mercer County Board of Commissioners are opposing the transfer of the 7,000 acres back to the Tribes and until they change their minds and decide to support or be silent we are not going to do business with them. Hugh Baker said he would recommend approval of the recreational lease, if they decide to support the Tribe.
- ITEM 5 ASCS Discussion: Hugh Baker directed Rich Schilf to meet with Roszella after the meeting to find out what was going on.
- ITEM 6 TRANSFER OF MEMORANDUM OF AGREEMENT (IHS) Hugh Baker entertained a motion that the Tribe accept the transfers from IHS. Moved to approve by Ted Lone Fight III, seconded by Jim Mossett. (Tex Branes and Denby Deegan sitting in at 12:00 noon)

ITEM 7 CONSENT TO GRANT RIGHT-OF-WAY Hugh Baker entertained a motion to approve the application to make the survey, provided that Rich Schilf puts in stipulations. Moved to approve by Ted Lone Fight III, seconded by Jim Mossett.

Hugh Baker entertained a motion to disapprove Betty Huesers' request to drop her lease on Allotment No.T283A, and the only way the lease can be dropped is if Delvin Foote picks up the lease at the same rate that Betty is paying. Moved to approve by Jim Mossett, seconded by Ted Lone Fight III.

Discussion: Hugh Baker said we should have something in our policy on cancelling leases.

VOTE: Unanimous-motion carried.

ITEM 10 ERNEST WILKINSON

Hugh Baker entertained a motion giving Ernest Wilkinson one (1) week to pay in full for Allotment No. 136A (\$45.00 an acre) for last years and this years, and approving a one (1) year lease to Mr. Wilkinson and if payment is not received in one (1) week trespassing will be investigate, also Donovan Iglehart's payment for Allotment No. 136A will be returned. Moved to approve by Ted Lone Fight III, seconded by Jim Mossett.

Discussion: Myrna Jacobs said Ernest Wilkinson already seeded Allotment No. 136A which was leased out to Donovan Iglehart. Myrna Jacobs said Ernest Wilkinson farmed Allotment No. 136A last year, although he did not have a lease on this allotment.
