 Welcome of High School students by Chairman
 Wilkinson.
- ITEM 04: PROPOSED BUSINESS ACTIVITY/POSSESORY TAX PROJECT: Resolution #90-05.
 Diane Johnson, Legal Attorney introduced Ahmed Kooros, Consultant with CERT providing technical assistance for implementation of Three Tribes taxation project.

The Tribal Business Council made a determination that we need more government revenue for the tribe so that we can, in turn, provide governmental services to the enrolled members. In any government, taxation is a method used to derive income.
