RESOLUTION/WHITE SHIELD SCHOOL: #93-68-JJR
Resolution read by Secretary Rabbithead.
This resolution authorizes the White Shield School to propose a contract with the Bureau of Indian Affairs for the administering of a repair/maintenance project and also authorizes the White Shield School Board President to sign documents necessary to secure such contracts with the Bureau on behalf

WHITE SHIELD SCHOOL (CON'T) of the Three Affiliated Tribes.

Mr. LaFrombois and Mr. White Bear were asked to comment on the resolution. The White Shield School had a project approved by the BIA in 1989. However nothing has been done on that project. They are attempting to get something done by this route. One of the things needed is a roof repair. If they are able to contract with the approval of this resolution, the could get the construction started within a couple of weeks. Chairman Wilkinson was thanked for going to Albuquerque with them in February to eliminate the delay of this project for another year. If it is not contracted, they will have to wait another year to start construction. It has been on hold for about four year.

Vice Chairman Johnson motioned to approve the resolution, seconded by Secretary Rabbithead.

Chairman Wilkinson acknowledged motion and second.

Councilman Mossett inquired about minutes from the school board. A reply was given that the school board has discussed this for quite some time.

ITEM 04: RESOLUTION/NATIVE AMERICAN RIGHTS FUND
Resolution read by Secretary Rabbithead.
This resolution pertains to a Special Counsel Contract with the NARF for legal services in the case of A-1 Contractors and Lyle Stockart vs. Honorable Willian D. Strate. This contract would be effective April 1, 1993 through March 31, 1994 at the rate of \$125 per hour plus other expenses not to exceed \$20,000 for such period.

Mr. Bear Don't Walk explained this case is in reference to whether a non-Indian can sue another non-Indian in Tribal Court. Mr. Bear Don't Walk further explained the aforementioned case.

Vice Chairman Johnson questioned our existing legal counsel. Mr. Bear Don't Walk explained this case would take the complete devotion of an attorney's time.

Discussion on the case. This is about two non-Indians using Tribal Court, where one is a resident of the reservation. There was also discussion on the financing of another attorney. Mr. Bear don't Walk is currently working on numerous cases for the Tribe and does not have the devoted time needed for this case.

Councilman Mossett questioned how this would benefit the Tribe and what would happen it the case is lost. Mr. Bear Don't Walk replied that non-Indians could then not be sued in Tribal court for civil matters. It is a matter of jurisdiction.

Councilman Gillette mentioned an Ordinance, 76-1, which is a requirement on all leases that are issued on behalf of the Tribe. It states that all non-Indians who have a dispute regarding their farm and pasture leases with the Tribe will go to Tribal Court.

Chairman Wilkinson entertained a motion to approve the resolution. There was no motion.

Resolution read by Secretary Rabbithead.
This resolution pertains to the Three Affiliated
Tribes pursuant to its constitutional authority, to
adopt, enact, and amend Chapter II, Section 5, of
the Three Affiliated Tribes Alcoholic Beverage
Control Ordinance to provide for the introduction,
sale, and use of alcoholic beverages on Sunday, and
also to include the provision for Tribal Sunday
Alcoholic Beverage Permits.

Chairman Wilkinson entertained a motion to approve.

Councilman Mossett motioned to approve, seconded by Vice Chairman Johnson.

Vote: 4 for, 3 opposed. Motion carried.

ITEM 07: RESOLUTION/FEE FOR SUNDAY PERMITS: #93-70-JJR
Resolution read by Secretary Rabbithead.
This resolution pertains to the establishment of
the fee for an annual Tribal Sunday Alcoholic Beverage Permit by the Tribal Council.

Chairman Wilkinson suggested the amounts of \$1,000 and \$10,000. Vice Chairman Johnson suggested \$25.

This is a flat fee for the permits, for whoever is licensed.

Discussion on the fee amount. Chairman Wilkinson entertained a motion and a fee amount. The fee determined was \$25 and no more than \$1,000.

Discussion on how many licenses the businesses are required to have. Response was two, one is a state license and the other must be a city or tribal license.

ITEM 08: RESOLUTION/FREEDOM ACT BILL: #93-71-JJR
Resolution read by Secretary Rabbithead.
This resolution is in support of Senators Kent
Conrad and Byron Dorgan to co-sponsor and support
the legislation that will protect Native American
religions and basic religious freedom, introduced
by Senator Inouye.

Mr. Bear Don't Walk commented this resolution basically deals with the attempt to secure religious freedom. It also protects sacred sites and the traditional use of peyote.

Chairman Wilkinson entertained a motion to approve.

Vice Chairman Johnson motioned to approve, seconded by Councilman Fast Dog.

Vote: 5 for, 0 opposed. Motion carried.

ITEM 09: RESOLUTION/VETERAN'S HOUSING: #93-72-JJR
Resolution read by Secretary Rabbithead.
This resolution pertains to Native American veteran direct loans to those qualified for the purchase, construction, or improvement of homes on trust

VETERAN'S HOUSING (CON'T) lands. This resolution is the adoption of an ordinance pertaining to leasehold mortgages which include eviction procedures, model residential leases, and a memorandum of understanding.

Chairman Wilkinson entertained a motion to approve.

Vice Chairman Johnson motioned to approve, seconded by Secretary Rabbithead.

Vote: 5 for, 0 opposed. Motion carried.

ITEM 10: RESOLUTION/FORMULATION OF A JURY LIST: #93-73-JJR Resolution read by Secretary Rabbithead.

This resolution amends the existing Tribal Court Procedures providing for jury lists, both civil and criminal, to a single, uniform system of formulating a jury list for jury trials. This provision shall amend and substitute Rule 24 (A) of the Criminal Procedures and Section 8 (d), (e), and (f) of the Civil Procedures of the Three Affiliated Tribes.

Mr. Mark Fox, Legal Assistant, stated the recommended alternative would be for the annual random selection of jurors from a list, prepared and presented by the Clerk of Tribal Court, of eligible voters residing on the Fort Berthold Reservation. Fifty (50) names shall be drawn from this list, by the official members of the Judiciary Committee, to comprise the permanent list to be utilized by the Clerk of Tribal Court for jury duty. Any replacements or substitutions shall be selected by the Tribal Clerk of Court, subject to the approval of the Tribal Judiciary Committee.

Chairman Wilkinson entertained a motion to approve.

Councilman Gillette motioned to approve, seconded by Vice Chairman Johnson.

Discussion on the pay schedule. Mr. Fox mentioned

Discussion on nominations of the Tax Commission. Gordon Blake explained a list was formed by the Tax Commissioner and the Legal Department of those people who would be the most qualified, and beneficial to the Tax Commission.

Karen Reynolds to the Gaming Commission.

Councilman Fast Dog explained a non-Indian is needed on the Gaming Commission, as Tom Gunderson has resigned.

Secretary Rabbithead mentioned his community, at a meeting on May 20, had voted to have representation on the Gaming Commission. Councilman Fast Dog replied the Gaming Commission feels the membership should stay as it is. Secretary Rabbithead mentioned that all segments should have representation on the Gaming Commission.

Discussion on representation of Gaming Commission.

There are currently seven members on the Gaming Commission. Councilman Fast Dog is the Chairman, Mark Bluestone is Vice Chairman, Sandy Eagle is Secretary, Delly Spotted Bear is Comptroller, Edmund White Bear, Vice Chairman Johnson, and Karen Reynolds is the non-Indian on the Commission.

Vice Chairman Johnson motioned to approve the resolution, seconded by Councilman Fast Dog.

Secretary Rabbithead requested consideration of a member of the Northeast Segment as an alternate for

GAMING COMMISSION (CON'T) the Gaming Commission. Motion amended to include the stipulation there be a designee from the Northeast Segment as an alternate.

Councilman Gillette mentioned the Gaming Ordinance states the commission shall have five members and one alternate, and of those five members, one shall be a non-Indian. Councilman Gillette further stated the standard procedure is to amend the Gaming Commission provision to include how many members are wanted.

Chairman Wilkinson asked for the vote.

Vote: 4 for, 1 opposed. Motion carried.

Chairman Wilkinson suggested the issue of membership be on the next full council agenda.

ITEM 15: RESOLUTION/FY '94 RECONTRACTING FOR PROGRAMS:
#93-77-JJR and #93-78-JJR
Resolutions presented by Secretary Rabbithead.
These resolutions authorize the resubmittal of contracts for the existing BIA and IHS contract programs.

Chairman Wilkinson entertained a motion to approve the resolutions.

Vice Chairman Johnson motioned to approve the resolutions, seconded by Secretary Rabbithead.

Vote: 5 for, 0 opposed. Motion carried.

ITEM 16: RESOLUTION/SUPPLEMENT FOOD COSTS/AGING SERVICES
Resolution read by Secretary Rabbithead.
This resolution pertains to the supplemental pay of
\$20,00.00, from the Tribe, for the Title VI Aging
Program for food costs.

Phoebe Dixon Aging Services Coordinator, explained the program does not get enough funding for Mandaree and New Town. Some of the administration costs Regular Council Meeting June 10, 1993 Page ten

AGING SERVICES (CON'T)

come out of this program funding which also cuts the amount of food that can be supplied. The food line was only about \$4,000.00, and this is not enough to feed the people.

Vice Chairman Johnson requested a breakdown of the actual costs for the cooks and the food who operate the Aging Services in Mandaree. Mrs. Dixon explained the cook salary for one year is \$9,396.00 plus fringe benefits. The food is bought in New Town.

Mrs. Dixon explained there are no grants currently available for her program. This is why she is requesting this money from the council. Treasurer Bird Bear suggested Mrs. Dixon write a request of additional funds for the chairman's signature from the central office of the Administration of Aging/U.S. Department of Health and Human Services.

Chairman Wilkinson entertained a motion to approve.

Councilman Fast Dog motioned to approve, seconded by Vice Chairman Johnson.

Discussion on available funds for the program. Treasurer Bird Bear stated there are none available.

Councilman Mossett questioned if this money will also feed Twin Buttes. Mrs. Dixon replied it will not, just Title VI communities and Twin Buttes is a Title III community. Mrs. Dixon no longer works with Title III.

Secretary Rabbithead asked Mrs. Dixon if she has someone working on the surveys. Mrs. Dixon replied she does not.

Councilman Mossett stated it takes about \$180,000 to feed the senior citizens and we get \$78,000 and \$26,000. Mrs. Dixon mentioned that is what we are supposed to get, however, we did not get much.

Councilman Mossett stated all of the communities
get counted for the program, but only three of the
communities get served. There is just not enough
money.

Treasurer Bird Bear stated we can give this money, but then we would be subsidizing the contracts. This is a contract the U.S. Government is supposed to deal with, when we give money, it is paying to work. The Tribe would be paying all the docket money to subsidize federal contracts.

Vote: 3 for, 4 opposed. Motion failed.

ITEM 17: RESOLUTION/SUPPLEMENT SALARY INCREASE
Resolution read by Secretary Rabbithead.
This resolution pertains to supplemental funding of \$9,996.56 from the Tribe for the pay increase of the Title VI Aging Program Director.

Chairman Wilkinson stated this has already been authorized. It just has to be carried out.

Treasurer Bird Bear reminded Mrs. Dixon he had previously asked Mrs. Dixon to see if her program would pay for that salary increase. Treasurer Bird Bear suggested Mrs. Dixon submit this request to those agencies along with the food source request in a letter with the chairman's signature.

THEM 18: RESOLUTION/SUPERVISION CHANGE
Resolution read by Secretary Rabbithead.
This resolution places the Title VI Aging Program
Director under the direct supervision of the
Chairman of the Human Resources Committee, which is
Secretary Rabbithead.

Chairman Wilkinson stated this is fundamentally wrong, we have an organizational structure to carry out administrative functions. Everyone has to work within the existing structure.

Chairman Wilkinson entertained a motion to approve.

Treasurer Bird Bear motioned to approve, seconded by Councilman Mossett.

This resolution pertains to the Tribal Council
putting a cease to waivers of the TERO requirements of the TERO Ordinance, in any way or form and
that any attempts to waive such requirements shall
cease immediatly.

Marcus Wells, Jr., explained each time these waivers are brought up, it challenges TERO. TERO needs the full support of the Council, any leeway in any way is causing problems. They are currently in three court cases and are in need of this support.

Chairman Wilkinson mentioned a billing statement for Bruce H. Lien for the TERO fee. This agreement with Bruce Lien Co. involved the waiver of the TERO fee and action was taken by the Council to waive the TERO fee. Chairman Wilkinson stated Lien Co. has complied with the employment practices.

Chairman Wilkinson stated the issue raised is FmHA's direct challenge to TERO on the FBCC project. They said if the TERO is waived, the loan documents can be processed and have the money available within 45 days. Chairman Wilkinson stated he received a fax from St. Joes stating the Tribe must waive the TERO requirements. Mr. Wells responded this stems from North Dakota's challenge to waive the TERO. Wells mentioned Cheyenne Mr. River, in South Dakota, had a housing project with the same type of loan and the TERO requirements were kept in place. Mr. Wells stated any time this is waived, the Tribe is waiving sovereigness.

Chairman Wilkinson entertained a motion to approve.

Marcus Wells, Jr. also commented on this issue and on the Motor Lodge renovation issue. Mr. Wells explained there were large amounts of supplies that came in for the renovations from all over just two weeks into the project. When Mr. Burr was asked about this, he turned them down, stating they were not interested in the first phase. They were just concentrating on phase II.
