### ITEM #1: CALL TO ORDER:

Meeting called to order by Chairman Russell D. Mason, Sr., at 9:32 a.m. Theresa Charging was asked to say the prayer before the meeting.

#### ITEM #2: ROLL CALL:

Roll call made by Acting Secretary Spotted Bear. Seven council members present, none absent. Quorum was established.

### ITEM #3: APPROVAL OF AGENDA:

Changes were made to the agenda as follows: Mark Fox requested that Item 5.b, Legal Department Budget, be added to the agenda. Motion was made by Mr. Gillette to approve agenda, as amended; seconded by Mr. Johnson. All in favor. Agenda approved.

**Discussion:** The Personnel Director Position was brought up at this time. Council discussed extending the closing date for this position to ten (10) working days, and to advertise the position until the 10th of February. Mark Fox to let Personnel know.

Motion:Mr. Gillette made the motion per discussion.Second:Mr. JohnsonVOTE:Unanimous.Motion carried.

### ITEM #4: BIA, FORT BERTHOLD, re Proposed Heirship Legislation.

Mr. Angus Fox, Acting Superintendent, BIA, along with Adeline Brunsell and Tom Wells, BIA Realty, were introduced. Angus advised that they wanted the council to be aware of the draft legislation being proposed for heirship land on Indian reservations. He stated they wanted to meet with the council to notify them of this pending legislation, and that they would be going to each of the segments and discussing this proposed legislation with the people at the segments, plus they planned to have a general meeting for the public. He said notices of meeting places, dates and times would be posted.

Mr. Fox then had Adeline Brunsell and Tom Wells answer any questions the council may have on the proposed legislation. Adeline stated this proposed legislation was being sent to all tribes nationwide for their input. The proposed legislation deals with heirship lands of 2% or less shares, plus minerals. If this legislation goes through, anyone with 2% or less shares, will lose these shares. If you don't do anything about the 2% or less shares that you own, when you pass on, these shares will automatically revert back to the tribe. The shareowner may gift deed, exchange, or buy other shares to get above the 2% minimum. In this legislation, non-member and non-Indian spouses would not be able to inherit reservation land anymore. This legislation will restrict inheritance. Comments on legislation are needed from Tribe by or before February 15, 1995.

Tom Wells advised that there are approximately 68 estates that will be affected by this law, as well. Adeline said if this law goes through, the council is going to have to set up a system as to how they are going to handle applications for land exchanges. About 1000 tribal landowners would be affected by this new legislation.

Chairman Mason requested Angus Fox to find out who is going to introduce this bill, Angus said he would do so.

At 10:15 a.m., a short break was taken. When council reconvened, Chairman Mason announced there was a matter of particular urgency to deal with regarding some documents that are important and necessary to the JTAC issue.

Urban Bear Don't Walk, Tribal Attorney, was requested to address and advise the council regarding the situation. After discussion, Mr. Gillette made a motion for legal counsel to proceed, and Mr. Johnson to do an informal visit with the former Tribal Chairman, Wilbur Wilkinson.

### ITEM #5.a: PETE FREDERICKS.

Mr. Fredericks was on the agenda, as he had requested to speak to the full council before the range allocations were made regarding removing land from range unit. However, Mr. Fredericks began discussing his application for range unit 5, therefore, at this point, Mr. Jim Mossett was asked to enter the chambers and present his plan of operation for the range unit. They were then both excused and council advised they would take both statements into consideration when making the allocation.

ITEM #5.b: LEGAL DEPARTMENT BUDGET.

NOTE: This was not addressed at this time.

### ITEM #6: RANGE UNIT ALLOCATIONS.

Mr. Kyle Baker, Administrator, TAT Natural Resources, and Mr. Paul Danks, GIS Director, Natural Resources, brought in the range unit applications. Mr. Baker said both Harley Texx Lone Bear and Myrna Jacobs were unable to attend the meeting, so he and Mr. Danks would present the applications to the council.

Mr. Danks stated they took basically everything out of the new grazing resolution for basic eligibility, and then they had established a priority list, and that the applicants were listed as to whom is the most qualified. Those with delinquent payments are automatically not eligible, according to the new grazing resolution.

Range Unit 001 - Applicant: Leo N. Baker Mr. Baker was called in. Since Mr. Baker was the only applicant and also previous permittee for this unit, it was awarded to him. Mr. Baker was so advised. Motion: Austin Gillette Second: Ed Hall

VOTE: Unanimous. Motion Carried.

Range Unit 002 - Applicants: Tillie Walker and Richard Danks. No verification of cattle was received from Tillie Walker, however, she owns most of the land in this unit, and she is the previous permittee, and has been for several years. Richard Danks, Alternate. Motion: Austin Gillette Second: George Fast Dog

VOTE: 5 for, 1 abstention, 1 absent. Motion Carried.

**Discussion:** Council stated that verification must be produced within ten (10) days. If an applicant is allotted a range unit, they have ten (10) days <u>flat</u> to come up with verification. This shall apply to **EVERYBODY!** 

Motion: After discussion, Mr. Gillette made a motion that all applicants must have verification of at least 40% ownership, and if they don't have it today, they must have it into Natural Resources by Monday, February 13, 1995; and, that the council will also select an alternate for the range units today.

Questions were asked regarding homesites and headquarters of applicants, wherein motion was made for Rockton Danks, Hollis Blake, Alternate. Ed Hall Motion: Daylon Spotted Bear Second: 5 for, 0 opposed, 1 abstention, 1 absent. VOTE: Motion Carried.

Chairman Mason then requested, on behalf of Mrs. Clyde (Inez) Baker, that Range Unit 036 be acted upon early, as she would like to make her presentation and leave, since Clyde was Senior Pallbearer for Catherine Fredericks. Council agreed. (See Chronological order for Range Unit 36.)

Range Unit 004 - Applicant: Ivan Johnson Mr. Johnson was the only applicant and the prior permittee, however, it was brought up that Mr. Johnson owed a fine to the BIA pertaining to pasture authorization.

Discussion: Mr. Johnson stated he had never filled out a pasture authorization, and did not feel it was necessary. Mr. Dreher stated the pasture authorization should have been done before the cattle went on the land. Mr. Johnson stated he also did not agree with the way the fine was calculated. Mr. Dreher said the amount owed by Mr. Johnson was calculated based on the tribal land. By CFR, they are supposed to charge the Area Director's minimum rates for non-indian-owned cattle on tribal land. However, this hasn't always been done in the past. Last October 1993, landowners were notified re pasturing authorization, along with the bill. The fines were calculated at 100% with the idea adjustments could be made afterward. After Mr. Dreher and Mr. Johnson agreed on the amount owed by Mr. Johnson, and Mr. Johnson stated he had no problem paying it, motion was made by Mr. Gillette to award to Ivan Johnson. Motion: Austin Gillette Second: George Fast Dog VOTE: 5 for; 1 abstention; 1 absent.

Both Mr. Johnson and Ron Brugh were given an opportunity to speak on behalf of their applications, and then were asked to step out. After lengthy discussion, it was decided that the fair way to solve this situation would be to bid it out.
