SPECIAL TRIBAL BUSINESS COUNCIL MEETING WEDNESDAY, JUNE 21, 1995, 02:45 P.M.

I. CALL MEETING TO ORDER & PRAYER.

Meeting called to order at 02:45 p.m. by Vice Chairman Edwin Hall. A moment of silent prayer was held.

II. ROLL CALL.

A. Secretary Daylon Spotted Bear called roll, as follows:

Secretary Spotted Bear announced five members present and two members absent. Quorum was established.

B. Tribal Loan Policy.

Discussion was held on tribal policy for loans. Loans are made only for emergency medical and funerals. There is a \$500 limit per funeral loan, per family. Preference for either of these loans shall be given to immediate family, i.e., spouse or children. This is a full council action policy, and all councilmen are asked to please adhere to this policy.

IV. NEW BUSINESS.

A. Temporary Appointment of Child Protection Investigator for Social Services.

Motion made by Austin Gillette to approve Social Services Director's request for temporary appointment of Gennea Siebel as Child Protection Investigator. Motion seconded by Daylon Spotted Bear.

Second: Daylon Spotted Bear Vote: 5 in favor. 2 absent.

Motion Carried.

B. Temporary Appointment of Attorney for Child Welfare Cases.

Motion made by Daylon Spotted Bear to employ Tom Gunderson as temporary consultant to assist the Child Welfare Program, until a staff attorney is hired.

Motion seconded by Mark N. Fox.

Discussion: Mention was made of the fact that Mr.

Gunderson has experience in tribal Child Welfare cases, and has, in the past, frequently assisted Child Welfare with their cases on a pro bono basis, i.e., he has not received payment for his services and has volunteered his services. Mr. Quale is the only attorney employed by the tribes at this time; and, consequently, is extremely busy and unable to devote his time to the child welfare cases. The courts will not hear tribal Child Welfare cases if they do not have an attorney present.

Mr. Fox advised the screening process for staff attorney has not yet been completed; however, the selection process may begin by next week.

Vote: 4 in favor. 1 opposed. 2 absent.

Austin Gillette made a motion to allow Tom Disselhorst to apply for the staff attorney position, and to be included in the screening process currently being done; seconded by Councilman Spotted Bear.

Vote: 4 in favor. 1 opposed. 2 absent.

Motion Carried.

C. Summer Intern Selections.

FayAnn Moberg presented the applicant list for summer intern positions, along with the credit hours and grade point averages for each student. Approximately thirty students had applied for summer intern positions. Interns are considered according to their number of credit hours, grades, dependents and need. Preference is given to senior students.

Motion was made by Mark N. Fox to select the top six students with the most credits, and include Leonard Hosie, based on need and dependents. Motion seconded by Austin Gillette.
