SPECIAL MEETING MINUTES

JULY 19, 1996

- A. CALL TO ORDER AND OPENING PRAYER. A Special Meeting on the 1996 Community Development Block Grant Program was called to order by Chairman Russell D. Mason, Sr., at 10:10 a.m. in the Tribal Council Chambers. A moment of silent prayer was held.
- B. ROLL CALL. Secretary Spotted Bear called roll: Six members present, Treasurer Mark N. Fox absent. Quorum established.
- C. CHAIRMAN'S ANNOUNCEMENT. Mr. Mason announced that Henry Buffalo, Tribal Gaming Attorney, would be present to give the council a briefing on the casino contract around the 30th of July. (Mr. Buffalo's visit was later confirmed for the Special Meeting on the 23rd of July.)
- D. R#96-158-DSB, 159, 160, 161 TO APPROVE WHITE SHIELD AND TWIN BUTTES 1996 CDBG PROPOSALS. Motion by Mr. Spotted Bear to approve the White Shield and Twin Buttes Proposals, seconded by Mr. Gillette. Vote: 5 in favor, 1 opposed, 1 absent. Carried.

- 1. R#96-158-DSB, proposed activities are #1/WS, New Field Clinic Building, New Senior Citizen Community Center; #2/TB, Expansion of Multi-Purpose Community Facility.
- 2. R#96-159-DSB, certification of Twin Buttes demographic/income data;
- 3. R#96-160-DSB, establishes Expansion of TB Multi-Purpose Community Facility as #2 Priority;
- 4. R#96-161-DSB, adopts Maintenance & Operation Plan for Proposed Expansion of TB Multi-Purpose Community Facility.
- E. R#96-162-DSB TO APPROVE FOUR BEARS 1996 CDBG PROPOSAL, AND TO INCLUDE THE FOUR BEARS LAGOON. MOTION was made by Mr. Edwin Hall to approve the Four Bears Proposal, seconded by Mr. Gillette. Motion and second AMENDED to include the Four Bears Lagoon in the resolution. Vote: 6 in favor, 1 absent. Carried. Note: Proposed activity is #3/FBs Segment Community Facility Expansion Project.

Vote: 4 in favor, 1 opposed, 1 abstained, 1 not present for vote.
